Overview

Lancashire Parking Services was established in 2009 as Lancashire County Council's parking enforcement centre. The service is responsible for the enforcement and administration of on-street parking restrictions to improve road safety for all road users, to improve the flow of traffic and to ensure emergency vehicles and public transport are able to travel without obstruction or delay.

The service also administers penalty charge notices issued in off-street car parks on behalf of district councils in Lancaster, South Ribble and Wyre. Lancashire County Council also became responsible for the Preston Bus Station car park in April 2014.

The council also operates on-street Pay & Display schemes in Preston and Lancaster, administers a number of residents' permit schemes throughout the county as well as providing a short-term parking dispensation service for tradesmen and emergency situations.

This document aims to provide information about the number of penalty charge notices issued by the council and the income and expenditure associated with parking enforcement across Lancashire.
