

NOTICE OF PROPOSAL
HIGHWAYS ACT 1980
LANCASHIRE COUNTY COUNCIL
(BLACK BULL LANE, FULWOOD, PRESTON CITY) (ROAD HUMPS)



NOTICE IS HEREBY GIVEN that in accordance with Section 90A of the Highways Act 1980, Lancashire County Council propose to introduce speed cushions in the following locations:

- a) Black Bull Lane, Fulwood, from a point 11.4 metres south of its junction with the centreline of Conway Drive for a distance of 3m in a southerly direction;
- b) Black Bull Lane, Fulwood, from a point 115.7 metres south of its junction with the centreline of Conway Drive for a distance of 3m in a southerly direction;
- c) Black Bull Lane, Fulwood, from a point 37.8 metres south of its junction with the centreline of Kings Drive for a distance of 3m in a southerly direction;
- d) Black Bull Lane, Fulwood, from a point 132.2 metres south of its junction with the centreline of Kings Drive for a distance of 3m in a southerly direction.

The road humps will have a maximum height not exceeding 75mm.

Statement of Reasons

The purpose of the proposal is to improve road safety and allow safe passage of pedestrians due to the increases in traffic coming from the town centre of Preston. The proposal aims to deliver improvements in road safety on Black Bull Lane.

- Creating safer street environments that makes it easier for people to walk, cycle or wheel to local places
- Improving sight lines for people trying to cross the road and reducing traffic speeds

The proposals include the following:

- Road humps to reduce vehicle speeds and improve road safety particularly for pedestrians and vulnerable road users
- Raised zebra crossing to facilitate safe crossing of the road and minimise conflict with motor vehicles
- Adjustment of length and positioning of existing school keep clear to facilitate the proposed changes to the road layout
