

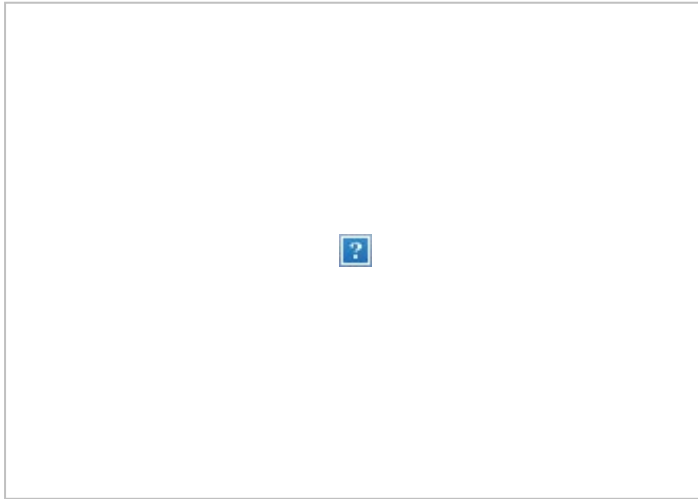

Hello Mr Kelly,

Your emails relating to the consultation letter received by the Ramblers Association into the application made to record Mere Lane at Holmeswood as a Restricted Byway have been passed to me.

The application was made by the Open Spaces Society and has been given the reference 807-770.

A copy of the application is attached.

With regards to your specific questions the evidence submitted is both historical map and documentary evidence and more modern user evidence.

Whilst the application has been made for a Restricted Byway the application is being investigated thoroughly by the County Council and as you should be aware depending on the evidence the Officer recommendation may be to make an order to record footpath, bridleway or restricted byway rights - or not to make an order at all.

If an order is made for the route to be recorded as a restricted byway then there is no need to make any separate application for a public footpath because the public would have a right of access on foot already so I am confused as to why you are asking if you need to make a separate application for a footpath over the route A-D-F.

If the County Council do not think there is sufficient evidence to record the route as a restricted byway (and Regulatory Committee agree) this does not mean the application would be rejected outright. If the evidence is sufficient to record public footpath or bridleway rights then this would be proposed in the alternative.

The purpose of this consultation is to ask if you have any information or evidence you may wish to present in relation to the application ahead of the matter being considered by the Regulatory Committee. If you have any comments you wish to make – or additional evidence relating to the history or public use of the route please send this to Ansar Sadiq.

Re Application for Definitive Map Modification, Mere Lane, Mere Brow.

Your Ref LSG4.AS002.894.18035

Thank you for your recent letter regarding the above matter.

As landowners and business owners we would like to make the following objections to the application. Mere Lane has been classed as a private road for many years, before our ownership, when Lancashire County Council owned all of the Holmeswood Estate. Signs at each of the lane stating that it is strictly for access only and no horses permitted have been present, as far as I know for at least 40 years.

1. Mere Lane is a narrow lane, offering **no footpaths** for the use of pedestrians. There is a deep, fast running ditch, running alongside the lane which, to people are not aware, could pose serious danger to life. This ditch takes all the excess water off the fields from Holmeswood. The bankings to the ditch are 12 ft and very steep and pose obvious dangers.

2. Tractors and large items of farm machinery use Mere Lane for access to fields. We have had instances where young children have been running around, unsupervised by adults causing a danger to life. If public footpath status was granted we feel that this would attract more children to the area, thus posing more health and safety problems.
3. Mere Farm is a busy working farm. Access to the farm is required by large heavy goods vehicles seven days a week from early morning into the evening for collection of produce. Due to the access and size of some of these vehicles they are unable to load and unload in the farmyard. This process has to take place on Mere Lane itself. As you can appreciate if we had members of the public walking along the lane at this time, this would pose a risk to health and safety both to our staff and to members of the public. Forklifts and other machinery are used to assist the loading and unloading of these vehicles.
4. Throughout the day/early evening we also experience quite a large amount of traffic due to two fisheries being situate on the lane. Again, the fact that there is no footpath, for pedestrians to walk along, poses a safety issue.
5. We have on a considerable amount of occasions, also had members of the public using the lane for the smoking/distribution of illegal substances. We feel that if public footpath was instated then this problem would more than likely increase.
6. On occasions over the years we have had members of the public trespassing onto our fields where vegetable crops are being grown . They often are under the impression that they are able to 'walk wherever they like' and have in the past caused detrimental damage to our crops. Our question to yourselves is how this could be prevented if public footpath status was granted? The same problems have arisen with people entering our woodland areas, in particular, young children who think it is a play area but of course, an area of this type can be very dangerous.
7. We have also had problems, with dogs being exercised along the road, not on a lead, and entering a field where sheep are grazing and causing injury to the animals. The police have record of this.
8. Mere Lane also appears to attract members of the public for sexual activity. We have photographic evidence of a male indecently exposing himself, again police were involved. If public footpath was granted we feel this again would attract more of this unacceptable activity.
9. Lastly, when we purchased the farm and lane from Lancashire County Council, we agreed to maintain and upkeep Mere Lane along with our

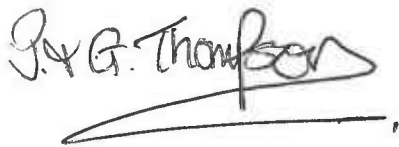
neighbours. If public footpath status was granted, who exactly would be responsible for the upkeep?

As per your request, I am attaching a full list of the occupants of Mere Lane, for whom the application will affect. I also enclose photographs of the sign, erected by LCC over 40 years ago stating the PRIVATE road status.

Also enclosed are photographs of large HGV waggons delivering and collecting from the farm. As you can see these are loaded and unloaded on Mere Lane, as due to the size of the vehicles they are unable to access the farmyard. These collections and deliveries are made at various times of the day, seven days a week.

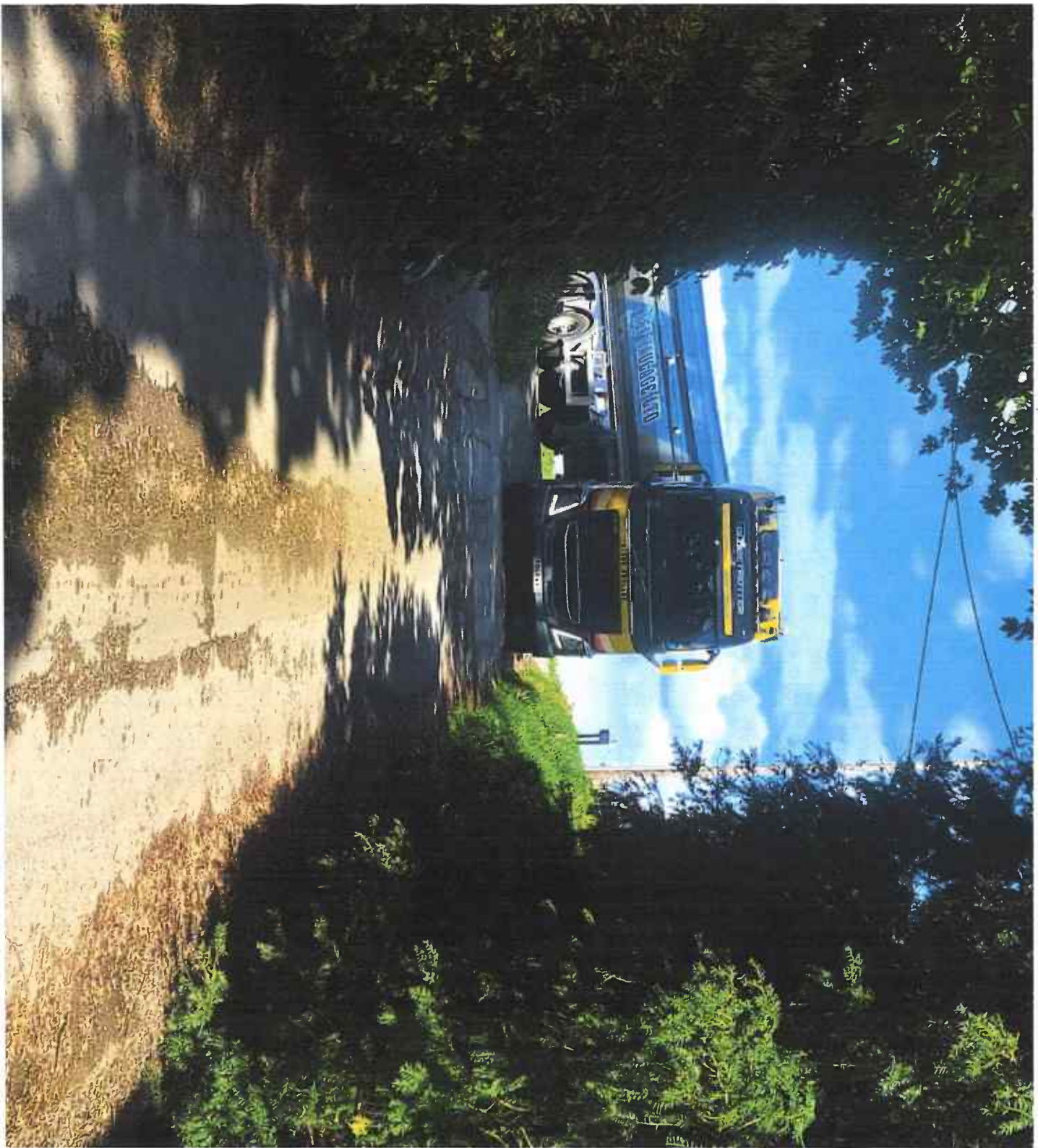

Good morning,

Thank you for your email.

Our Public Rights of Way Officer has provided a response to each point, in italics below:

1, **Purpose and Objective:** Could you please clarify what will be achieved by designating Mere Lane as a restricted byway? Understanding the intended outcomes of this designation will assist us in assessing its potential impact on the local community and environment.

The application to record Mere Lane as a restricted byway has been made because the applicant considers that there is evidence to show that the route is already a restricted byway (ie that public rights already exist) but that they are not recorded on the Definitive Map.

Because this is the case any assessment on the potential impact on the local community or environment are not relevant and cannot be taken into consideration.

Relevant considerations are what evidence there is to show that the route already exists as a restricted byway, what evidence exists to suggest that it is not a restricted byway and/or whether there is evidence to suggest that it should be recorded as a public footpath or bridleway instead – on the basis that there is evidence that it has been dedicated as a footpath or bridleway but not as a historical public carriageway.

Other relevant considerations would be evidence that any public rights that did exist have subsequently been stopped up.

2. **Preservation of Bridle Path:** Will the designation of Mere Lane as a restricted byway affect the status of the existing bridle path in the area? We seek confirmation regarding the continuity and accessibility of equestrian routes for residents and visitors alike.

The application that the parish council have been consulted on does not in any way affect any other routes within the area but is specific only to what public rights may exist over the route marked between points A-G on the attached plan.

3. **Applicant and Purpose:** Could you disclose the identity of the entity or individual who has submitted the application for the designation of Mere Lane as a restricted byway? Additionally, it would be helpful to understand the primary purpose or rationale behind this application.

Anyone can make an application to record a public right of way on the Definitive Map and Statement. This particular application was made by the Open Spaces Society who were made aware of the fact that only a short stretch of Mere Lane was recorded as a public right of way but that the remaining length had been used by the public in the past and that a public footpath (FP0816026) was recorded as starting/terminating on the unrecorded section of

Mere Lane.

4. **Adoption Status:** Is there a plan for the restricted byway on Mere Lane to be formally adopted by Lancashire County Council? Understanding the potential adoption status of this proposal will inform our discussions and decision-making process.

The only matter under consideration is whether there are public rights along the full length of Mere Lane and what those public rights may be. Part of Mere Lane is already recorded as part of FP0816022 and this is publicly maintainable as a public footpath. Depending on the outcome of the investigation additional public rights may be recorded on the Definitive Map and these rights may – depending on when they came into being – mean that the rest of the route is publicly maintainable as a footpath, bridleway or restricted byway – but not as a modern mechanically propelled public vehicular highway.

There is no intention to 'adopt' Mere Lane as a publicly maintained vehicular highway and this is a completely separate procedure to the investigation that is currently being undertaken.

In light of the aforementioned inquiries, we respectfully request that no decision be made regarding the proposed restricted byway until we have received clarification on these matters and have had the opportunity to discuss them at our next council meeting scheduled for 10th June. It is imperative that we thoroughly consider all relevant information and implications before reaching a conclusion on this important issue.

It is unlikely that a report on this matter will be presented to the County Council Regulatory Committee until September but we would appreciate any comments that you may wish to make as soon as possible.
