Job Purpose

- The position will require a good knowledge of fleet maintenance and management and the
- requirements of providing a varied operating fleet, including managing service level agreements and capital budgets.
- A good knowledge statutory and regulatory requirements in relation to Fleet Management will be essential.
- Managing the fleet to ensure efficient deployment and use.
- Developing and managing Service Level Agreements.
- Ensuring fleet and hire vehicles remain compliant with Operator Licence, insurance, and registration requirements.
- Efficient management of the fleet ensuring whole life costs and on-going maintenance and other costs are properly accounted for in decision making.
- Writing concise and articulate reports.
