





This route is shown on the OS six inch map from 1848




Lancashire LXVIII (includes: Hesketh with Becconsa Surveyed: 1844 to 1845 Published: 1848



The full route is clearly shown on this one inch OS map in 1896







This Bartholomews half inch map from 1904 clearly shows the route in full






This 1930 25 inch OS map clearly shows the route in 1931






This 1:25,000 map clearly shows the route in 1946





Tithe Map from 1841, Plot number 59 on the map is part of the full route


