SECTION 53 OF THE WILDLIFE AND COUNTRYSIDE ACT 1981

THE DEFINITIVE MAP AND STATEMENT OF PUBLIC RIGHTS OF WAY FOR THE COUNTY OF LANCASHIRE

THE LANCASHIRE COUNTY COUNCIL WATERY LANE FROM HAUNDERS LANE TO LIVERPOOL ROAD, MUCH HOOLE DEFINITIVE MAP MODIFICATION ORDER 2023

The above Order, made on the 29 March 2023, if confirmed as made, will modify the Definitive Map and Statement of Public Rights of Way for the area, by recording a Bridleway from the junction with Haunders Lane and Footpath 7-8-FP2 running in a generally easterly direction along an enclosed stone surfaced track to where the track ends and the route continues running immediately to the south of a hedge over a strip of land which consists largely of a watercourse between the hedge line and field edge footpath (Footpath 7-8-FP2). The route is crossed by Footpath 7-8-FP2 and continues in a broadly east south easterly direction along the watercourse through to Liverpool Road (A59).

With the exception of the bounded stone surfaced track carrying the footpath 7-8-FP2 the Order route is currently largely unusable as it is recorded within the old boundaries of the historical route known as Watery Lane within which the watercourse is located.

The total length of the route is 1.04 kilometres and the width of the route varies between 2.5 metres and 10 metres.

THE LANCASHIRE COUNTY COUNCIL WATERY LANE FROM HAUNDERS LANE TO LIVERPOOL ROAD, MUCH HOOLE DEFINITIVE MAP MODIFICATION ORDER 2023

The above Order, made on the 29 March 2023, if confirmed as made, will modify the Definitive Map and Statement of Public Rights of Way for the area, by recording a Bridleway from the junction with Haunders Lane and Footpath 7-8-FP2 running in a generally easterly direction along an enclosed stone surfaced track to where the track ends and the route continues running immediately to the south of a hedge over a strip of land which consists largely of a watercourse between the hedge line and field edge footpath (Footpath 7-8-FP2). The route is crossed by Footpath 7-8-FP2 and continues in a broadly east south easterly direction along the watercourse through to Liverpool Road (A59).

With the exception of the bounded stone surfaced track carrying the footpath 7-8-FP2 the Order route is currently largely unusable as it is recorded within the old boundaries of the historical route known as Watery Lane within which the watercourse is located.

The total length of the route is 1.04 kilometres and the width of the route varies between 2.5 metres and 10 metres.

(TEMPORARY SPEED RESTRICTION) ORDER 2022 (TEMPORARY AMENDMENT) ORDER 2023

The Lancashire County Council ("the County Council") in exercise of its powers under Section 14(1) (a) of the Road Traffic Regulation Act 1984, as amended, (the Act), and of all other enabling powers, HEREBY makes the following Order:-

The Lancashire County Council (BARTLE LANE, WOODPLUMPTON, PRESTON CITY) Temporary Prohibition Of Through Traffic) Order 2022, is hereby temporarily Amended in that:

i. To amend Article 3 as follows:
1. The prohibition will be operative from 0000 hours on 3rd January 2023 until 0000 hours on 30th June 2023 or until completion of the works within this period.

This Temporary Amendment Order shall come into operation on Friday 21st April 2023 and may be cited as "The Lancashire County Council (BARTLE LANE, WOODPLUMPTON, PRESTON CITY) (Temporary Prohibition Of Through Traffic) Order 2022 (Temporary Amendment) Order 2023"
