

NOTICE OF PROPOSAL
HIGHWAYS ACT 1980
LANCASHIRE COUNTY COUNCIL
(ARTHURS LANE, GOAT WILLOW DRIVE AND ROWAN LANE,
HAMBLETON, WYRE BOROUGH) (JUNCTION TABLES)

NOTICE IS HEREBY GIVEN that in accordance with Section 90A of the **Highways Act 1980**, Lancashire County Council propose to introduce junction tables in the following locations:

Junction Table 1

- Arthurs Lane, Hambleton, from the intersection of the centreline of Rowan Lane and Arthurs Lane for a distance of 12 metres in a north westerly direction;
- Arthurs Lane, Hambleton, from the intersection of the centreline of Rowan Lane and Arthurs Lane for a distance of 11.1 metres in a south easterly direction;
- Rowan Lane, Hambleton, from the intersection of the centreline of Arthurs Lane for a distance of 11.27 metres in a north easterly direction.

The junction table will have a maximum height not exceeding 75mm.

Junction Table 2

- Arthurs Lane, Hambleton, from the intersection of the centreline of Goat Willow Drive and Arthurs Lane for a distance of 16.98 metres in a north westerly direction.
- Arthurs Lane, Hambleton, from the intersection of the centreline of Goat Willow Drive and Arthurs Lane for a distance of 16.29 metres in a south easterly direction;
- Goat Willow Drive, Hambleton, from the intersection of the centreline of Arthurs Lane for a distance of 10.89 metres in a north easterly direction.

The junction table will have a maximum height not exceeding 75mm.



Statement of Reasons

The purpose of this proposal is to introduce two new junction tables on Arthurs Lane. One situated at the junction with Rowan Lane and one situated at the junction with Goat Willow Drive. This proposal seeks to slow traffic and allow safe passage of pedestrians due to the increase in traffic from the new housing development.

These proposals are being carried out under a Section 278 Agreement by the developer and are linked to the new housing development.
