FOOTPATH NO. 129 CHIPPING (DEFINITIVE MAP MODIFICATION) ORDER 2014

This Order is made by Lancashire County Council ("the Authority") under Section 53(2)(b) of the Wildlife and Countryside Act, 1981 ("the Act") because it appears to that Authority that The Definitive Map and Statement of Public Rights of Way for the County of Lancashire require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(iii) and 53(3)(c)(i) namely the discovery by the Authority of evidence which (when considered with all other relevant evidence available to them) shows that there is no public right of way over land shown in the map and statement as a public footpath and that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, namely a public footpath.

The Authority have consulted with every local authority whose area includes the land to which the Order relates. Lancashire County Council hereby order that:


- 1. For the purposes of this Order, the "relevant date" is 30<sup>th</sup> December 2014.
- 2. The Definitive Map and Statement of Public Rights of Way for the County of Lancashire shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as The Lancashire County Council Deletion of Part of Public Footpath No. 129 Chipping and Addition of Footpath from Fish House Lane to Footpath No. 129 Chipping (Definitive Map Modification) Order 2015.

## PART I

### MODIFICATION OF THE DEFINITIVE MAP

### DESCRIPTION OF PATH OR WAY TO BE DELETED

The full unrecorded width of part of Public Footpath No. 129 Chipping commencing south east of Old Hive on Fish House Lane, Chipping at Point A on the Order plan and extending in a north easterly and then north westerly direction through the gardens to the side and rear of Old Hive, Chipping (through points B-C-D-E-F-G on the Order plan) to point H. A distance of approximately 75 metres.

### DESCRIPTION OF PATH OR WAY TO BE ADDED

A Public Footpath varying between 2.4 and 6 metres in width, from Fish House Lane south of 12 Old Hive (Point I on the Order plan) in a general north easterly direction across a tarmacked surface passing in front of the access gates of 12 and 14 Old Hive to meet Public Footpath No. 129 Chipping north of 10 Old Hive at point H on the Order plan; a total distance of approximately 20 metres.

Compass points given are approximate."

Length: "0.24 km"




