Your letter of July 28th is written by yourself whilst the letter to me of 25th June came from the Pendleside Bridleways Association (Secretary.)

In the Inspectors report para: 10.16 refers to horse use of the route presented by the supporters.

Para: 12. refers to 12 years of Horse use.

Para: 13.16.6. refers to 4 claims of horseback use of 20 years so it would be untrue to say that this evidence was ignored - it is said to be too weak.

Ownership of the land

pre 1810 it is clear that most if not all the land concerned was owned by Thomas Parker and after by his son Edward Parker.

My recent purchases reunites much of that except for the sections now owned by Mr Wilson of Cockerhill.

The report does not say there is "No ownership of this land." Ownership is referred to in paragraphs: 11-(8) - 11-(10) - 13-(8) - 13-(10)

The Inspector did not - "ignore evidence even though he had the power to upgrade the route to a Bridleway." The Inspector states in para: 13.5 that a request for it to be shown as a bridleway 'is inconsistant with most of the contentions made' (and he had not sufficient evidence to so modify the order.)

So your letter to the new owner of Longhill is deliberately misleading in three respects:

- (1) the Inspector did not ignore user evidence
- (2) the implication that a sufficient case was presented for the route to become a bridleway is untrue.
- (3) the Inspector never stated there was no ownership of the land.

Now I do not know why you might wish to mislead a person you thought was not at the inquiry or in receipt of the report.

I do not know why you should (as chairman) have me written to by someone other than the person who writes to the 'new owner.'

It is simple to say that it was solely your attitude at the inquiry that turned me against such use of the route by horseriders whilst I was open minded before.

Whilst Miss Taylor had assembled a team of fifteen helpers and witnesses, presented 103 detailed 103 detailed pages of evidence only 15 minutes prior to the hearing and attempted to dominate the Inspector with her inadequate legal knowledge and the five objectors myself being on the receiving end of one 20 minute question that required a simple yes or no for an answer - it is little wonder we are wary of you.

We still cannot understand why you wanted 4 wheel drivers and motorbikes to use a route such as this or what evidence you ever thought there really was to support public vehicular use.

Let us be clear. Only prior to the hearing did I have no objection to horses using this route.


