

**NOTICE OF PROPOSAL
HIGHWAYS ACT 1980**

LANCASHIRE COUNTY COUNCIL

**(CATFORTH ROAD, ROSEMARY LANE AND SCHOOL LANE, CATFORTH,
PRESTON CITY) (ROAD HUMPS AND CHICANES)**



NOTICE IS HEREBY GIVEN that in accordance with Sections 90A and 90G of the **Highways Act 1980**, Lancashire County Council propose the following:

A) Introduce road humps in the following locations:

- 1) Catforth Road, Catforth, from a point 14.5 metres south of its junction with the centreline of Green Lane for a distance of 7.8 metres in a south easterly direction;
- 2) Catforth Road, Catforth, from a point 15.5 metres north west of its junction with the centreline of Jane Lane for a distance of 7.8 metres in a north westerly direction;
- 3) Catforth Road, Catforth, from a point 84 metres north of its junction with the centreline of Saddlers Fold Court for a distance of 7.8 metres in a northerly direction;
- 4) Catforth Road, Catforth, from a point 67.3 metres south of its junction with the centreline of Saddlers Fold Court for a distance of 7.8 metres in a southerly direction;
- 5) Catforth Road, Catforth, from a point 177.7 metres north west of its junction with the centreline of Square Lane for a distance of 7.8 metres in a north westerly direction;
- 6) Catforth Road, Catforth, from a point 21 metres north west of its junction with the centreline of Square Lane for a distance of 7.8 metres in a north westerly direction;
- 7) Catforth Road, Catforth, from a point 10.6 metres south east of its junction with the centreline of Bay Horse Lane for a distance of 7.8 metres in a south easterly direction;
- 8) Catforth Road, Catforth, from a point 100.3 metres south east of its junction with the centreline of Bay Horse Lane for a distance of 7.8 metres in a south easterly direction;
- 9) Catforth Road, Catforth, from a point 18 metres north west of its junction with the centreline of School Lane for a distance of 7.8 metres in a north westerly direction;
- 10) Catforth Road, Catforth, from a point 70.4 metres south east of its junction with the centreline of School Lane for a distance of 7.8 metres in a south easterly direction;
- 11) Catforth Road, Catforth, from a point 23.6 metres south east of its junction with the centreline of Benson Lane for a distance of 7.8 metres in a south easterly direction;
- 12) Rosemary Lane (C330), Catforth, from a point 21.3 metres south of its junction with the centreline of Rosemary Lane (U10914) for a distance of 7.8 metres in a southerly direction;
- 13) School Lane, Catforth, from a point 58.6 metres north east of its junction with the centreline of Catforth Road for a distance of 7.8 metres in a north easterly direction;
- 14) School Lane, Catforth, from a point 172.5 metres north east of its junction with the centreline of Catforth Road for a distance of 7.8 metres in a north easterly direction;
- 15) School Lane, Catforth, from a point 238.7 metres north east of its junction with the centreline of Catforth Road for a distance of 7.8 metres in a north easterly direction;
- 16) School Lane, Catforth, from a point 296.3 metres north east of its junction with the centreline of Catforth Road for a distance of 7.8 metres in a north easterly direction.

The flat top road humps will have a maximum height not exceeding 75 millimetres.

B) Introduce chicanes in the following locations:

- 1) Catforth Road, Catforth, from a point 188.75 metres south east of its junction with the centreline of Jane Lane for a distance of 27.9 metres in a south easterly direction. The chicane will have a minimum carriageway width of 3.675 metres to the parallel opposing kerb. The overall length of this chicane is 27.9 metres.
- 2) Catforth Road, Catforth, from a point 138.33 metres north west of its junction with the centreline of Blackleach Lane (north of the canal bridge) in a north westerly direction for a distance of 26.92 metres. The chicane will have a minimum carriageway width of 3.975 metres to the parallel opposing edge of carriageway. The overall length of the chicane is 26.92 metres.

Statement of Reasons

The traffic calming measures are to be implemented to compliment a reduction in the speed limit to 20mph and 30mph and waiting restrictions. It is proposed to install 16 flat top road humps and 2 Chicanes that will have a positive impact in reducing vehicle speeds and improving safety for all road users.
