(C161 HIGHER LANE AND C163 LEES LANE, DALTON, WEST LANCASHIRE BOROUGH) (TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2024

**NOTICE IS HEREBY GIVEN** that Lancashire County Council have made an Order under **Section 14(1) (a) of the Road Traffic Regulation Act 1984**, as amended, the effect of which will be to temporarily prohibit traffic on the roads set out in this notice.

- 1. No person shall cause any motor vehicle to proceed over the following lengths of highway in the West Lancashire Borough:
  - i. C161 Higher Lane, Dalton from the Northern boundary of the property named Grange Farm to the access road to the property named Oakwood Cottage.
  - ii. C163 Lees Lane, Dalton from C161 Higher Lane, Dalton to the North West boundary of the property named Roseheath.
- 2. Nothing in this order shall apply to persons engaged in the carrying out of the works.
- 3. The prohibition will be operative from 0800 hours until 1700 hours on Thursday 15<sup>th</sup> August 2024 or until completion of the works within this period.
- 4. Vehicular access for residents will be maintained whenever and wherever possible. Pedestrian access to properties will always be maintained.
