

**NOTICE OF MAKING**  
**ROAD TRAFFIC REGULATION ACT 1984**  
**LANCASHIRE COUNTY COUNCIL**  
**(WYCOLLER COUNTRY PARK PICNIC SITE MAIN CAR PARK,  
WYCOLLER ROAD, COLNE, PENDLE BOROUGH) (OFF STREET  
PARKING PLACES) ORDER 2024**

**NOTICE IS HEREBY GIVEN** that on 17 July 2024 Lancashire County Council made the above Traffic Regulation Order under Sections 32 and 35 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

1. Designate the land situated at grid reference 392605:439527, measuring approximately 88 metres by 118 metres known as Wycoller Country Park Picnic Site Main Car Park, as being an off street car parking place for the purposes of Section 32 of the Road Traffic Regulation Act 1984. The land hereby being known as the "Wycoller Country Park Picnic Site Main Car Park" and as set out in the above Order as the land edged red.
2. Introduce a tariff of pay and display parking charges as set out in the Schedule to this notice for the use of these off street parking places.
3. Introduce 2 disabled person's parking spaces which will be situated on the Main Area Parking Area in this off street parking place.

This Order will come into force on the 22 July 2024. Any person wishing to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with, that person may, within 6 weeks from the date on which the order is made, apply for the purpose to the High Court.
