## NOTES ON MILL LANE AND DARK LANE , EARBY.

OS maps back to 1853 on 6" scale all show Mill Lane and Dark Lane as walled/hedged tracks with a footpath alongside much of their length. The earliest (1853) 6" shows cottages along the north-western edge of Dark Lane adjoining the track to Marl Field together with other cottages immediately across the field. Traces of the cottages alongside Dark Lane are to be seen in the wall and two house platforms in the field adjoining the wall.

The David & Charles Sheet 16 reprint of the old series 1" OS map shows walled/hedged tracks as on the 1853 6" map but is not sufficiently detailed to show footpaths . although the relative importance of a route from Kelbrook above Moor Hall is apparent.

The 1825 Enclosures map of Thornton -in- Craven shows Mill Lane and Dark Lane as walled/hedgedtracks but without footpaths alongside although many other footpaths are shown.

The 1956 OS 6" map shows the Urban District Boundary following along the edge of part of Dark Lane nearest the footpath , while a boundary marker is in the lane itself.

The inference is that , on the balance of probabilities , both lanes are old thoroughfares which have passed out of use due to narrow width and subsequent deterioration and have been partially replaced by a footpath alongside on the worst stretches.

In my own memory Mill Lane has always been passable at the Stoney Bank end for some 200 yds., while the Mill Brow end was the access to allotments/hen-pens below the lane. Dark Lane has always been virtually impassable since my childhood.

A search of the schedule to the 1825 Enclosures Act for Thornton -in- Craven shows that neither Mill Lane nor Dark Lane are included in the list of public/private/high/ bridle/occupation roads or tracks specified in the schedule , but since they are clearly shown on the map they must have been pre-existing.

There is no specific reference to Dark Lane in the schedule but Mill Lane is cited twice as an established boundary :-

(i) "- allot and award unto the Reverend William Roundell one allotment or parcel of land Number 71 on the said plan situate at Rake Bank Lane containing eleven perches , bounded by ancient inclosures on or towards the east and north , by Rake Bank Lane aforesaid on or towards the west , and by Mill Lane on or towards the south -" -I remember this parcel as a hen-pen on the other side of Stoney Bank Road from Banks Farm barn.

.) "- allot and award unto John Sunderland the younger and his heirs one allotment "or parcel of landNumber 16 on the said plan situate at Mill Brow containing twelve perches, bounded by ancient inclosures on or towards the east and south, by <u>Hill</u> <u>Lane</u> aforesaid on or towards the west, and by a road on or towards the north -" -this plot has been built on probably earlier this century.


In both these allotments Will Lane is obvicually regarded as an established preexisting boundary with the allotments located at each end of the lane on the vesteradownhill side.

The lands on each side of these lanes are now and since the 1825 enclosures in different ownership with none of the owners having a claim to the lanes themselves. We mustassume on the balance of probabilities that these lanes have been thoroughfares in common use as far back and indeed before we can trace from the records.

There appears to be no reason why these lanes should not be cleared .drained , and suitably surfaced for use as public bribleways and the adjoining footpaths closed and returned to agricultural use in the ownership of the landowners on whose land they now run.
