

THORNTON INCLOSURE.

I WILLIAM PILKINGTON, late of Hensall, but now of Thorne, in the County of York, Gentleman, the sole Commissioner named in and by an Act of Parliament made and passed in the 59th Year of the Reign of his late Majesty, King George the Third, intitled "An Act for inclosing and exonerating from Tithes, Lands in the Manor and Parish of Thornton, in Craven, in the County of York," and in obedience to the same, and also to the Directions of an Act passed in the 41st Year of the Reign of his said Majesty, intitled "An Act for consolidating in One Act certain Provisions usually inserted in Acts of Inclosure, and for facilitating the Mode of proving the several Facts usually required on the passing of such Acts,"

Do hereby give Notice,

That I have set out and appointed the following public Carriage Road, and Highway, and private Carriage and Occupation Roads, over and across the Lands and Grounds by such first-mentioned Act directed to be divided and inclosed, that is to say,

One public Carriage Road and Highway, of the Width of Thirty Feet, as and where the same is staked out, commencing at Moor-Gate, and leading in a South-ly Direction over Kelbrook-Moor to the North End of Cob-Lane, which Road I distinguish by the Name of *Moor-Gate Road*.

One private Carriage and Occupation Road, of the Width of Thirty Feet, as and where the same is staked out, commencing at Dodgson House Road on Bleary-Moor, and leading in a North Westerly Direction across Allotments sold to John Sunderland, Jonathan Gray, and Sir John Lister Kaye, Bart. to an ancient Lane leading to Standridge Clough, which Road I distinguish by the Name of *Standridge Clough Road*.

One other private Carriage and Occupation Road, of the Width of Thirty Feet, as and where the same is staked out, commencing at the Colne and Skipton Turnpike Road, on Bleary-Moor, near Bleary-Side, and leading in a North Westerly and Northerly Direction across Allotments sold to Sir John Lister Kaye, Bart. John Buck, and the Rev. William Roundell, respectively, to an ancient Lane near a Place called East Bow Head, and which Road I distinguish by the Name of *Bleary Side Road*.

One other private Carriage and Occupation Road, of the Width of Twenty-four Feet, as and where the same is staked out, commencing at the East End of Hanber-Lane, and leading in a South Easterly and Easterly Direction to the South West Corner of an Allotment set out to the Rector of Thornton for Glebe, thence in an Easterly Direction across the same Allotment, and another Allotment also set out to the said Rector for Tithes, to the North East Corner of an Allotment sold to Sir John Lister Kaye, and thence in a South Easterly Direction to the North End of the Wentcliff Head Road, which Road I distinguish by the name of *Hanber-Lane Road*.

One other Private Carriage and Occupation Road, of the Width of Twenty-one Feet, as when and where the same is now staked out, commencing at Moor-Gate Road, near Thick Bank, and leading in an Easterly Direction to the West Corner of an Allotment set out to the said Sir John Lister Kaye for his Manorial Right, and thence in the same Direction across the last mentioned Allotment to ancient Inclosures belonging to Richard Bradley Wainman, Esq. which Road I distinguish by the name of *Thick Bank Road*.

One other private Carriage and Occupation Road, of the Width of Twenty-four Feet, as and where the same is now staked out, branching out from the Moor-Gate Road on Kelbrook Moor, and leading in a South Easterly Direction across an Allotment sold to the said Sir John Lister Kaye, to Hard Clough, and thence in the same Direction to an Allotment sold to Thomas Benson Pease, Esq. which Road I distinguish by the Name of *Hard Clough Road*.

One other private Carriage and Occupation Road, of the Width of Twenty-one Feet, as and where the same is now staked out, commencing at the Bleary Side Road, near the North East Corner of an Allotment sold to the said Sir John Lister Kaye, on Bleary Moor, and leading in a Westerly Direction across the said Allotment, to an Estate belonging to the said Richard Bradley Wainman, called Cobby-House, which Road I distinguish by the Name of *Cobby-House Road*.

One other private Carriage and Occupation Road, of the Width of Twenty-one Feet, as and where the same is now staked out, commencing at Standridge Clough Road, at the North West Corner of an Allotment sold to the said Sir John Lister Kaye, and leading in an Easterly Direction across the said Allotment to an Estate belonging to Mr. John Whittock, called Higher Vardens, which Road I distinguish by the Name of *Higher Vardens Road*.

One other private Carriage and Occupation Road, of the width of Twenty-one Feet, as and where the same is now staked out, commencing at the Moor-Gate Road, near a Place called Knowl, and leading in a South Easterly and Easterly Direction across an Allotment sold to George Worrall, Esq. to an ancient Inclosure belonging to the said Sir John Lister Kaye, called Meadow, which Road I distinguish by the Name of *Knowl Road*.

One other private Carriage and Occupation Road, of the Width of Twenty-one Feet, as and where the same is now staked out, commencing at Moor-Lane, on the West Side of an Allotment sold to Samuel Sunderland, and leading in an Easterly Direction across the said Allotment to an ancient Inclosure belonging to Agnes Wormald, and another ancient Inclosure, called Dick Field, belonging to Martha Breare, Amy Topham, and Ann Topham, which Road I distinguish by the Name of *Dick Field Road*.

One other private Carriage and Occupation Road, of the Width of Twenty-one Feet, as and where the same is now staked out, branching out of the Colne and Skipton Turnpike Road, near Howshaw Bar, and leading in a Westerly Direction over an Incroachment, lying on the West Side of the said Turnpike Road to a Farm called Kitchen, belonging to the said Richard Bradley Wainman, which Road I distinguish by the Name of *Kitchen Road*.

One other private Carriage and Occupation Road, of the Width of Twenty-one Feet, as and where the same is now staked out, branching out of the said Colne and Skipton Turnpike Road, and leading in a Westerly Direction over the said Incroachment to certain Farms and Lands called Burnt Hill and Brown Hill, belonging to Mr. John-Shaw and the said Richard Bradley Wainman, respectively, which Road I distinguish by the Name of *Burnt Hill Road*.

One other private Carriage and Occupation Road, of the Width of Twenty-one Feet, as and where the same is now staked out, commencing at an ancient Lane near Rake Banks, and leading in a Southerly Direction over an Allotment sold to the said Sir John Lister Kaye, to an ancient Inclosure belonging to John Whitaker, which Road I distinguish by the Name of *Rake Banks Road*.

And I do also give Notice,

That I have prepared a Map or Plan, in which such Roads are accurately laid down and described, and that I have deposited such Map or Plan with my Clerk, Mr. THOMAS EVERARD UPTON, Solicitor, Leeds, for the Inspection of all Persons concerned.

And I also give Notice,

That I shall hold a Meeting at the House of Mrs. Bond, on Wednesday, the Tenth Day of March next, at Eleven o'Clock in the Forenoon, when and where all Persons, who may think themselves injured or aggrieved by the setting out of the said Roads, may attend and state their Objections to the same.—Dated this Fourteenth Day of February, 1824.
