

**NOTICE OF MAKING**  
**ROAD TRAFFIC REGULATION ACT 1984**  
**LANCASHIRE COUNTY COUNCIL**  
**(SMITHY STREET AND STATION ROAD, BAMBER BRIDGE, SOUTH**  
**RIBBLE BOROUGH) (REVOCATION, PROHIBITION OF WAITING AND**  
**LIMITED WAITING) ORDER 2024**

**NOTICE IS HEREBY GIVEN** that on 24 July 2024 Lancashire County Council made the above Traffic Regulation Order under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

1. Revoke the following:
  - a) The "Lancashire County Council (South Ribble Area) (On Street Parking Places, Prohibition and Restriction of Waiting) Consolidation Order 2009" insofar as it relates to the following:
    - i. Items (189)c)(v) and (189)c)(vi) of Schedule 10.01;
    - ii. Items (6)a)(i) and (6)b)(ii) of Schedule 12.066.
  - b) The "Lancashire County Council (Station Road, Longbrook Avenue, Charleston Court, Lychfield Drive, Bamber Bridge, South Ribble Borough) (Part Revocation and Prohibition of Waiting) Order 2009" insofar as it relates to Items 1) and 2) of Schedule 1;
  - c) The "Lancashire County Council (Station Road Area, Bamber Bridge, South Ribble Borough) (Revocation, Prohibition of Waiting, Limited Waiting and Prohibition of Loading) Order 2019" insofar as it relates to Item h) of Schedule 2;
  - d) The "Lancashire County Council (Station Road, Bamber Bridge, South Ribble Borough) (Prohibition of Waiting) Order 2010" in full.
2. Introduce a prohibition of waiting in the following lengths of road:
  - a) Smithy Street, Bamber Bridge, both sides, from its junction with the centreline of Station Road for a distance of 10 metres in a north westerly direction;
  - b) Station Road, Bamber Bridge, the east side, from a point 6.5 metres north of its junction with the centreline of Wesley Street for a distance of 50.5 metres in a southerly direction;
  - c) Station Road, Bamber Bridge, the east side, from a point 6 metres north of its junction with the centreline of Sergeant Street for a distance of 27.5 metres in a southerly direction;
  - d) Station Road, Bamber Bridge, the north west side, from a point 35 metres southwest of its junction with the centreline of Lychfield Drive for a distance of 47.5 metres in a north easterly direction;
  - e) Station Road, Bamber Bridge, the west side, from a point 18 metres north of its junction with the centreline of Hopwood Street for a distance of 47 metres in a northerly direction;
  - f) Station Road, Bamber Bridge, the west side, from a point 18.5 metres south of its junction with the centreline of Edward Street for a distance of 51 metres in a northerly direction;
  - g) Station Road, Bamber Bridge, the west side, from a point 12.5 metres south of its junction with the centreline of Hopwood Street for a distance of 18.5 metres in a northerly direction;
  - h) Station Road, Bamber Bridge, the west side, from a point 34 metres south of its junction with the centreline of Smithy Street for a distance of 41.5 metres in a northerly direction.
3. Introduce a limited waiting parking place for 1 hour with no return within 1 hour Monday to Saturday between 8am and 6pm in the following lengths of road:
  - a) Station Road, Bamber Bridge, the east side, from a point 21.5 metres south of its junction with the centreline of Sergeant Street for a distance of 17 metres in a southerly direction;
  - b) Station Road, Bamber Bridge, the west side, from a point 6 metres north of its junction with the centreline of Hopwood Street for a distance of 12 metres in a northerly direction.

This Order will come into force on the 29 July 2024. **LSG4/894.15963/AFR.** Any person wishing to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with, that person may, within 6 weeks from the date on which the order is made, apply for the purpose to the High Court.
