Good Morning Simon,

I would like to make on behalf of Network Rail a formal objection to the above Order made by Lancashire CC on 20th July 2022.

In addition, I have attached the initial objection that was sent in March 2022 when Network Rail first became aware of the DMMO application.

I would like to reiterate the comments previously made in that Network Rail object on the basis that;

- Our historical records show that upon construction of the railway, Sod Hall Lane was a
 private road and the crossing was provided to maintain access for the adjacent
 landowner/s. It has been accepted that public rights have been established and recorded
 as on foot only, but that these have never been any more than that.
- If the route were to become a bridleway, the infrastructure at the crossing would need to re-considered. Items such as mounting blocks and accessible bridle gates are usually required, and in addition, the sighting distances may not be sufficient as the distance required for equine users is further than for pedestrians.
- There would be an unacceptable increase in risk at the crossing, where the sighting may
 be deficient, and the use of the crossing changes and possibly increases. The mitigation
 measures that may be required, such as telephones or warning lights would result in a
 huge cost to Network Rail (and ultimately to the taxpayer).

Furthermore, I would like to address some points that have been raised in the 'Agenda Item 8 Regulatory Committee Meeting to be held on 22nd June 2022' document that you provided and after a further inspection of historical railway files that Network Rail hold.

• The Book of Reference that accompanies the Liverpool, Ormskirk & Preston Railway Act 1846 records the route as a 'private or occupation road'. The document highlights the ambiguity of this description, but the term 'occupation' is a widely used term in the railway and describes a road with private rights for owners of adjacent land, or a road over which someone else has a right of way. Network Rail still use this term to describe a road that pre-existed the construction of any railway, and the authorised users of such roads are considered to be those with land that abuts the road/way. These roads may be owned by one party, or sometimes several with each being responsible for the maintenance of their section.

- The use of the term 'private' in the Book of Reference description suggest that it may have been a toll//turnpike road of some description, and after further researching historical railway files, it appears that there may well have been some form of toll on this route, again suggesting that it was not a public carriageway. There is a hand written note dated 5th September 1933 stating that a nearby elderly resident had said that the toll had ceased approximately 20 yrs. prior, so that would be about 1903.
- The land and house which the Gate House sits on (point D) on the plan, was prior to 1903 owned by a third party and housed a railway employee. The railway company purchased the land and house in 1903 when that landowner died, and the railway employee remained in tenancy. It is unclear exactly what this person's position was in relation to the crossing, but at that time the nearby Midge Hall Station was in situ alongside a goods yard which would have employed many people. This may explain some of the census information that is referred to in the document.
- The Railway Clauses Consolidation Act 1845 (RCCA 1845) that is incorporated into the Liverpool, Ormskirk & Preston Railway Act, contains approximately 165 clauses which are common to all railway authorising acts after 1845, and which saved Parliament's time in considering these Private Bills. Section 68 refers to works that were constructed for the protection and accommodation of lands adjoining the railway, which includes gates, bridges, arches and passages under or over the railway including level crossings. Sod Hall level crossing was provided to accommodate the already existing private or occupation road for the benefit of the land owners that the road served, and possibly other users if it was indeed a toll/turnpike road. RCCA 1845 s.47 specifically refers to where the railway crosses any turnpike or public roads on the level, and outlines the requirement for gates etc as well as 'proper persons to open and shut such gates'. Therefore, If indeed there was some form of gatekeeper employed at any time, this does not necessarily mean that the route was public. It does however, support the suggestion in the historical files that this route was a private toll/turnpike road that pre-existed the railway, and users of the road paid to pass over it at various points.
- Whilst the historical files held by Network Rail allude to some confusion over the years between approximately the early 30's to the early 60's, as to the exact status of the route, the files hold written correspondence from adjacent land owners who, during the mid 60's were consulted on the closure of the crossing, and they did not object. The files state that any crossing attendance that may still have been provided at that time, was withdrawn in 1968, not long after the nearby Midge Hall station and goods yard was closed. It was recognised at this point that there was a claimed public footpath and that would be retained, and by the early 70's those that required vehicular access over the crossing were given keys to the gates, and telephones were provided so that they could contact the signaller.

In conclusion, Network Rail hold the opinion that this has never been considered to be a public crossing (other than those currently on foot), and we would support the conclusions given in the document that the historical evidence of the route having become a higher status for the public is insufficient. Further information on the above can be supplied if required.

I am writing with reference to your recent correspondence in relation to an application to record a bridleway along Sod Hall Lane – your reference above.

I can confirm that Network Rail would strongly object to this on the basis that;

- Our historical records show that upon construction of the railway, Sod Hall Lane was a
 private road and the crossing was provided to maintain access for the adjacent
 landowner/s. It has been accepted that public rights have been established and recorded
 as on foot only, but that these have never been any more than that.
- If the route were to become a bridleway, the infrastructure at the crossing would need to re-considered. Items such as mounting blocks and accessible bridle gates are usually required, and in addition, the sighting distances may not be sufficient as the distance required for equine users is further than for pedestrians.
- There would be an unacceptable increase in risk at the crossing, where the sighting may be deficient, and the use of the crossing changes and possibly increases. The mitigation measures that may be required, such as telephones or warning lights would result in a huge cost to Network Rail (and ultimately to the taxpayer).

I have already been in consultation with one of your colleagues Jayne Elliot in relation to several similar applications made by the British Horse Society, and I wonder if it would be possible for you to provide me with a list of the applications, so that I can start to investigate those that will affect the railway.


