

## **Explanatory statement**

The footpath for which this application is made runs from the junction of Newburgh footpaths 33 and 40 to the junction of Newburgh footpaths 39 and 34 (See maps enclosed).

The points A and B on the maps submitted are at these junctions. They relate to Grid References SD487093 and SD489091 respectively.

The footpath provides a link between these points and avoids the use of a very busy road without pavement either side, when walking between Newburgh and Dalton or on a circular route from either village.

The application is made on the basis that there has been regular use of the path without challenge for a long period, in some cases well beyond the twenty years required to establish it as a right of way.

## FOOTPATHS IN NEWBURGH

This leaflet and map, produced by the Footpaths Committee of Newburgh Parish Council, is intended to provide the necessary information for local walkers. It is hoped that as a result more people will use the footpaths, and reports of any problems would be appreciated.

The parish is bounded to the west by the River Tawd, to the north by Deans Lane and the railway, to the east by the River Douglas and Higher Lane, and to the south by Beacon Lane and Vale Lane. The old county constituency boundary passes through the parish, and follows the 'boundary brook' through Cobbs Clough ('top woods' or 'bluebell woods') to the River Douglas.

## Official Footpaths

There are fourteen numbered footpaths in the parish, on the County Council's definitive map. The numbering reveals that five of them (31 to 35) were originally in the old Wigan Rural District, and the other nine (39 to 47) are from the old Ormskirk Urban District. Not all are in good condition, and diversions have been proposed for two of them; details of each are given below.

The canal towpath, not strictly a footpath, and the property of the Water Authority, has recently been restored, and provides a useful path in excellent condition.

## 'Unofficial ' Footpaths

Not numbered on the definitive map, but clearly marked on many published maps, these have been regularly used in the past. The Footpaths Committee will seek their inclusion on the definitive map, and would appreciate details of their current use.

There is a rough track from the end of Tears Lane, along Lowes Lane and on to Cobbs Brow Lane. There is also a footpath from the sharp corner of Tabby's Nook which emerges on Tears Lane, one from the playing field up to 'bluebell woods' in Cobbs Clough, and another from the quarry on Cobbs Brow Lane across to the farm on Beacon Lane.

### A Tour of the Official Footpaths

This can be conveniently done in two sections, which may be combined as indicated.

(A) In the centre of the village, take the signposted path by the side of the Saddlery. This is footpath 46 which passes through the gate, along the left side of the hedge, to a dilapidated footbridge over the 'boundary brook', at the other side of which footpath 31 begins. This is usually obscured by cultivation, but strike out across the field in the same direction as 46, until a path travelling at right-angles is reached. If you turned left here, you would continue on 31 to Higher Lane, and from that path footpath 32 branches off south-east to emerge higher up Higher Lane, at a broken metal stile. However, turn right instead, on to footpath 33, and head for the old tree standing in mid-field.

At the tree, 33 turns left (south) along a discernible track to the field boundary, there going right and then left to follow the edge of the woods in Cobbs Clough, until it drops down to a crude but solid footbridge across the brook, at one of the pleasantest spots in the parish. Over the bridge begins footpath 40 (currently with a proposed diversion); it goes at an angle up the bank and then follows the opposite side of the woods, south to the point where it turns sharp right (west) along a field boundary to Cobbs Brow

Lane. There is however an 'unofficial' footpath continuing south along the edge of the woods, down to footpath 39. 39 actually begins on Cobbs Brow Lane, by the quarry, and it follows the left (north) side of the field boundary to another footbridge over the brook.

Footpath 34 begins at the other side of the bridge, up the bank, but is then totally obscured by cultivation. Strike out across the field, and aim for the right hand end of a hedge, where a broken metal stile marks the point where two paths diverge. Footpath 35 goes south, then east, emerging on Higher Lane by Crofts Nurseries; ahead, 34 continues, also to Higher Lane, emerging at the Dungeon Lane junction. From here, walk down Higher Lane back to the village. The walk is about  $2\frac{1}{2}$  miles in total. Alternatively, use the Parbold parish footpaths to the canal bank and join the walk described next.

(B) From the village, walk into Parbold, and at the windmill take the left (south) bank of the canal, past the moored boats. This is actually Parbold footpath 11, which becomes Newburgh footpath 42 at the point where it crosses the River Douglas and enters our parish. It is badly overgrown with brambles, and a detour to the left may be necessary, but it leads to the point where the canal narrows, and where once stood a bridge. From here footpath 41

ald take you to Ash Brow, whilst footpath 43 continues along the canal bank to the point where footpath 45 (unclear) stikes out across a cultivated field to Back Lane, and would bring you to the footpath sign almost opposite the school. Continue the canal route on footpath 44; after Culvert Lane it is very obscured but continues as far as Deans Lane, where to continue to Spencers Bridge it is necessary to cross under the canal to use the towpath on the opposite bank.

At Spencers Bridge, cross the road bridge; footpath 47 is signposted on the right, and leads across a field to Course Lane at Rose Cottage. The house extension actually obstructs this path, and a diversion is being negotiated; skirt the house to the right and join Course Lane by the bridge. Ahead is Tawd Vale Scout Camp, with many excellent paths, but at the time of writing no public right of way. Return along Course Lane with care, into the village. This walk is about  $3\frac{2}{4}$  miles; the two together about  $5\frac{1}{2}$  miles.
