

**NOTICE OF PROPOSAL**  
**ROAD TRAFFIC REGULATION ACT 1984**  
**LANCASHIRE COUNTY COUNCIL**  
**(B6601 ROUNDABOUT AND LEAPERS WOOD ROAD, OVER KELLET,**  
**LANCASTER CITY) (PROHIBITION OF PEDESTRIANS AND CYCLES)**  
**ORDER 202\***

**NOTICE IS HEREBY GIVEN** that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

1. Revoke the "Lancashire County Council (B6601 Roundabout and Leapers Wood Road, Over Kellett, Lancaster City) (Prohibition of Pedestrians, Equestrians, Cycles and Horse Drawn Vehicles) Order 2022" in full.
2. Introduce a prohibition of pedestrians in the following lengths of road:
  - a) B6601 Roundabout, Over Kellet, from its junction with Leapers Wood (B6601) for its full circumference;
  - b) Leapers Wood Road (B6601), Over Kellet, all sides, from its junction with Kellet Road (B6254) for its entire length.
3. Introduce a prohibition of cycles in the following lengths of road:
  - a) B6601 Roundabout, Over Kellet, from its junction with Leapers Wood (B6601) for its full circumference;
  - b) Leapers Wood Road (B6601), Over Kellet, all sides, from its junction with Kellet Road (B6254) for its entire length.
