ROAD TRAFFIC REGULATION ACT 1984 LANCASHIRE COUNTY COUNCIL

(B6601 ROUNDABOUT AND LEAPERS WOOD ROAD, OVER KELLET, LANCASTER CITY) (PROHIBITION OF PEDESTRIANS, EQUESTRIANS, CYCLES AND HORSE DRAWN VEHICLES) ORDER 2022

The County Council of Lancashire ("the Council") in exercise of its powers under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984, as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

1. <u>Definitions and Interpretation</u>

For all the purposes of this Order the terms described in this Article shall have the meanings specified:

"Pedal Cycle" means a unicycle, bicycle, tricycle, or cycle having four or more wheels, not being in any case mechanically propelled unless it is an electrically assisted pedal cycle of such class as is to be treated as not being a motor vehicle for the purposes of the 1984 Act.

2. Prohibition of Pedestrians

Save as is hereinafter provided, no pedestrian shall, except upon the direction or with the permission of a police constable in uniform, proceed along the lengths of road referred to in Schedule 1 to this Order.

3. Prohibition of Equestrians

Save as is hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit to be ridden, or shall lead, any horse along the lengths of road referred to in Schedule 2 to this Order.

4. Prohibition of Cycles

Save as is hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, ride or cause or permit any Pedal Cycle to be ridden along the lengths of road referred to in Schedule 3 to this Order.

5. Prohibition of Horse Drawn Vehicles

Save as is hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any horse-drawn vehicle, to proceed along the lengths of road referred to in Schedule 4 to this Order.

6. Exemptions

Nothing in Articles, 2, 3, 4 and 5 of this Order shall render it unlawful to cause or permit any vehicle to travel along any part of the lengths of road referred to therein for so long as may be necessary to enable:

- a) the fire brigade, ambulance or police purposes in pursuance of statutory powers or duties;
- b) for the purposes of a local authority in pursuance of statutory powers or duties if it cannot conveniently be used for such purpose in any other road;

- c.) if it cannot conveniently be used for such purpose in any other road to be used in connection with any of the following:
 - i) building, industrial or demolition operations;
 - ii) the removal of any obstruction to traffic;
 - iii) the maintenance, improvement or reconstruction of the said lengths of roads;
 - iv) the laying, erection, alteration or repair in or in land adjacent to the said lengths of road of any sewer or of any main, pipe or apparatus or the exercise of any other statutory power or duty for the maintenance and supply of gas, water or electricity or of any telecommunications system as defined in Section 4 of the Telecommunications Act 1984.

7. Miscellaneous

The prohibitions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made, or having effect as if made, under the Act or by or under any other enactment.

8. Commencement of Order

This Order shall come into force on the 02nd day of May 2022 and may be cited as the "Lancashire County Council (B6601 Roundabout And Leapers Wood Road, Over Kellet, Lancaster City) (Prohibition Of Pedestrians, Equestrians, Cycles And Horse Drawn Vehicles)(Prohibition Of Driving) Order 2022"

Schedule 2 – Prohibition of Equestrians


- a) B6601 Roundabout, Over Kellet, from its junction with Leapers Wood (B6601) for its full circumference.

- a) B6601 Roundabout, Over Kellet, from its junction with Leapers Wood (B6601) for its full circumference.
- b) Leapers Wood Road (B6601), Over Kellet, all sides, from its junction with Kellet Road (B6254) for its entire length.

Schedule 4 - Prohibition of Horse Drawn Vehicles

- a) B6601 Roundabout, Over Kellet, from its junction with Leapers Wood (B6601) for its full circumference.
- b) Leapers Wood Road (B6601), Over Kellet, all sides, from its junction with Kellet Road (B6254) for its entire length.
