Improved pedestrian Access from Bus Station to Market St

Bus Station proposed to be reconfigured in partnership with Pendle Borough Council. Exact layout subject to design.

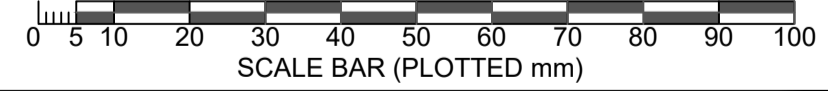
