

ROAD TRAFFIC REGULATION ACT 1984

LANCASHIRE COUNTY COUNCIL

**(BAY HORSE LANE, CATFORTH ROAD, SCHOOL LANE AND SQUARE LANE, CATFORTH,
PRESTON CITY)**

(REVOCAION, RESTRICTED ROAD AND 30MPH SPEED LIMIT) ORDER 2015

The County Council of Lancashire, in exercise of its powers under Sections 83 and 84 of, and Part IV of Schedule 9 of the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

1. Revocation

a) The "The Lancashire County Council (Catforth Road, Catforth, Preston Borough) (40 mph Speed Limit and Derestricted Road) Order 1991" is hereby revoked in full.

b) The "The Lancashire County Council (Catforth Road and School Lane, Catforth, Preston Borough) (40 mph Speed Limit) Order 1997" is hereby revoked in full.

2. Restricted Road

No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road set out in schedule 1 to this Order, which shall become restricted roads (as defined in section 82(1)(a) of the Road Traffic regulation Act 1984).

3. 30mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road set out in schedule 2 to this Order.

4. Exemption

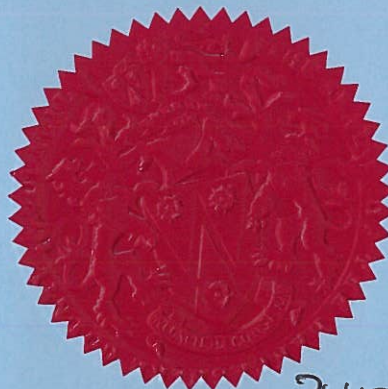
No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those Regulations.

5. Commencement of Order

This Order may be cited as the "Lancashire County Council (Bay Horse Lane, Catforth Road, School Lane And Square Lane, Catforth, Preston City) (Revocation, Restricted Road And 30mph Speed Limit) Order 2015" and shall come into force on the 3rd day of April 2015.

Schedule 1 – Restricted Roads

1. Catforth Road - From a point 340 metres south of the centre line of Jane Lane to a point 98 metres north of the centreline of Benson Lane.
2. School Lane – From the centreline of Catforth Road for a distance of 178 metres in a northeasterly direction.

Schedule 2 – 30mph speed limits

1. Bay Horse Lane - From the centreline of Catforth Road for a distance of 125 metres in a westerly direction.
2. Catforth Road - From a point 30 metres south of the centre line of Jane Lane for a distance of 340 metres in a southerly direction.
3. Catforth Road - From a point 98 metres north of the centre line of Benson Lane to a point 50 metres south of the centreline of Benson Lane.
4. School Lane – From a point 178 metres north east of the centreline of Catforth Road for a distance of 98 metres in a northeasterly direction.
5. Square Lane - From the centreline of Catforth Road for a distance of 145 metres in a westerly direction.
