

ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL

(CATFORTH ROAD, LEA LANE, ROSEMARY LANE AND SCHOOL LANE, FYLDE, PRESTON AND WYRE) (REVOCATION, 20MPH AND 30MPH SPEED LIMITS) ORDER 202*

The County Council of Lancashire, in exercise of its powers under 83(2) and Section 84 and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

1. Revocation

- a) Those parts of the "Lancashire County Council (Bay Horse Lane, Catforth Road, School Lane and Square Lane, Catforth, Preston City) (Revocation, Restricted Road and 30mh Speed Limit) Order 2015", as set out in Schedule 1a to this Order, are hereby revoked.
- b) That part of the "Lancashire County Council (Avice Pimblett Way, Lea Lane, Sandy Lane and William Young Way, Preston City and Fylde Borough) (Revocation, 30, 40 and 50mph Speed Limits) Order 2024", as set out in Schedule 1b to this Order, is hereby revoked.

2. 20mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 20mph on any of the lengths of road as set out in Schedule 2 to this Order.

3. 30mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 30mph on any of the lengths of road as set out in Schedule 3 to this Order.

4. Exemption

No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those Regulations.

5. Commencement of Order

This Order shall come into force on the ** day of ** 202* and shall be cited as the "Lancashire County Council (Catforth Road, Lea Lane, Rosemary Lane And School Lane, Fylde, Preston And Wyre) (Revocation, 20mph And 30mph Speed Limits) Order 202*".

Schedule 2 - 20mph Speed Limit

- a) Catforth Road, Catforth, Preston, from a point 76.5 metres north of its junction with the centreline of Green Lane to a point 95 metres north west of its junction with the centreline of the northern arm of Blackleach Lane.
- b) School Lane, Preston, from its junction with Catforth Road for a distance of 493 metre in a north easterly direction.

Schedule 3 - 30mph Speed Limit

- a) Catforth Road, Catforth, Preston, from a point 95 metres north west of its junction with the centreline of the northern arm of Blackleach Lane to its junction with Rosemary Lane (C330).
- b) Catforth Road, Catforth, Preston, from a point 110 metres south of its junction with Carrs Green/Lewth Lane to a point 76.5 metres north of its junction with the centreline of Green Lane.
- c) Catforth Road, Inskip with Sowerby, from its junction with Carrs Green/Lewth Lane for a distance of 110 metres in a southerly direction.
- d) Lea Lane (C330), Preston, the entire length.
- e) Rosemary Lane (C330), Preston, the entire length.
- f) School Lane, Preston, from a point 493 metres north east of its junction with Catforth Road to its junction with Moorside Lane/Lewth Lane.
