2. I completed a user evidence form in 2013 confirming my usage of the way that runs from Moss Lane via footpath 21 to Hunger Hill, Wrightington.
3. I have known the way since the 1960s and have used it ^{*predominantly*} on horseback. *+ on foot blackberry picking.*
4. The route has always followed the same course.
5. I have never known any stiles, gates or fences across the route.
6. I have never worked for any landowner over which the way passes, nor have I ever been a tenant over which the way passes.
7. I have never been stopped or turned back when using the route with a horse, nor have I ever heard of anyone else having been stopped or turned back using route with a horse. However, I should point out that I was temporarily held on one occasion when a householder parked across the way who responded to a polite request and let me through. Apart from this, I have never been stopped or questioned or deliberately turned away when riding the route. I have used it on my own and in the company of other riders over the years.
8. I have never been told by any owner or tenant of the land crossed by the way, or by anyone in their employment that it was not public.

9. I have never seen any notice on or near the route, nor have I ever asked permission to use it.

**WITNESS STATEMENT OF
PATRICIA A. VEALL**

1. My name is Patricia A. Veall and I live at 9 Langdale Avenue, Swinley, Wigan WN1 2HW. I was born in 1948 and have lived locally. I am retired.
2. I completed two user evidence forms in 2013 confirming my usage of the path that runs from Moss Lane via footpath 21 to Hunger Hill, Wrightington. The first form detailed use of the route on horseback whilst the second form detailed use of the route on foot and on a bicycle.
3. I have known the way for over 60 years and have used it on a bicycle, on foot and on horseback from the late 1950s to 2013. I would go along the route from St Joseph's Church to St Joseph's School to catch the bus home – often on daily. I rode the way with my friends weekly. I have also used it on foot since about 1953 and on my bike from 1960. I also rode my horse from Prescott's Farm to Hunger Hill.
4. I had used this way regularly as a girl, being a pupil at St Joseph's School. We walked and rode with friends up and down the route which we knew as 'the Pads'. On a school day, the church provided transport to school, but my brothers and others had to make our own way home after school to St Joseph's Church to catch a bus home which meant going down the Pads from St Joseph's Church from St Joseph's School daily.
5. My brothers and I walked the pads on a daily basis to and from school. We caught the bus from St Joseph's Church. The Pads were the shortest way from school to the bus stop. I also hacked with friends and rode my bike up

and down the Pads. Nobody ever stopped us or said otherwise. Everybody used it.

6. The route has always followed the same course.
7. I have never known any stiles, gates or fences across the way.
8. I have never worked for any landowner over which the route passes, nor have I ever been a tenant over which it passes.
9. I have never been stopped or turned back when using the way with a horse, nor have I ever heard of anyone else having been stopped or turned back using it with a horse. Nobody ever stopped us or said otherwise. Everybody used it.
10. I have never been told by any owner or tenant of the land crossed by the route, or by anyone in their employment that it was not public.
