Schools Forum September - September 2024

This is the first newsletter of the 2024/25 academic year and the Schools Forum hopes that all colleagues had an enjoyable summer. This is Issue 8 of the Lancashire Schools Forum eNewsletter' a Pre-Forum Edition, which deals with matters to be considered at the early autumn term 2024 cycle of meetings.

School Funding Arrangements 2025/26

Across government, budgets for 2025-26 are yet to be finalised due to the change in government, this includes the 2025-26 Schools' Budget. Therefore, the ESFA has not been able to publish the schools and high needs operational guides in July as per normal practice.

The ESFA have stated that the annual funding cycle will differ from previous years. New timelines will be confirmed following decisions on the core schools budget settlement for 2025-26.

Schools should be aware that's this may impact the local authorities funding timescales.

Updates will be provided once the schools and high needs operational guidance is published by the ESFA.

De-delegations Consultation 2025/26

Due to the delayed ESFA funding announcements, the Schools Funding Arrangements and De-delegation Consultation is postponed. The proposed service de-delegations are as follows:

- Staff costs Public Duties/Suspensions
- Heritage Learning Service (Museum Service) Primary Schools Only
 - Schools Requiring additional Support
 - Primary Inclusion Hubs Primary Schools Only
 - Children's Champions

There are no changes to the service offers since 2024/25. The consultation will be issued to all maintained Primary and Secondary Schools once the ESFA finalised the Schools Budget.

Clawback at March 2025

In July 2024, the Lancashire Schools Forum voted to Implement Clawback to excess balances at March 2024.
