ROAD TRAFFIC REGULATION ACT 1984 LANCASHIRE COUNTY COUNCIL

(VARIOUS ROADS, CHORLEY, FYLDE, HYNDBURN, RIBBLE VALLEY, SOUTH RIBBLE AND WEST LANCASHIRE) (REVOCATION AND VARIOUS SPEED LIMITS (24-25 NO1)) ORDER 202*

The County Council of Lancashire, in exercise of its powers under Sections 82(2), 83(2) and 84 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

1. Revocations

- a) Those parts of the "The Hyndburn Borough Council (Restricted Road)(Altham Lane, Huncoat/Altham) Order 1988", as set out in Schedule 1a to this Order, are hereby revoked.
- b) Those parts of the "The Borough Of Hyndburn A678 Burnley Road Altham (Restricted Road) (Prohibition Of Waiting) Order 2003", as set out in Schedule 1b to this Order, are hereby revoked.

2. 20mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 20mph on any of the lengths of road as set out in Schedule 2 to this Order.

3. 40mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 40mph on any of the lengths of road as set out in Schedule 3 to this Order.

4. <u>De-Restriction</u>

The lengths of road as set out in Schedule 4 to this Order shall cease to be restricted roads for the purposes of Section 81 of the Act.

5. Exemption

No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those Regulations.

6. Commencement of Order

This Order shall come into force on the ** day of ** 202* and shall be cited as the "Lancashire County Council (Various Roads, Chorley, Fylde, Hyndburn, Ribble Valley, South Ribble And West Lancashire) (Revocation And Various Speed Limits (24-25 No1)) Order 202*".

Schedule 3 - 40mph Speed Limit

- a) Altham Lane, Altham, from a point 20 metres north east of its junction with the centreline of Peter Grime Row to its junction with Burnley Road.
- b) Bury Lane, Withnell, from its junction with A674 Chorley Road to a point 302 metres north of its junction with Calder Road (U5909).

Schedule 4 - De-Restriction (national speed limit will apply)

- a) Moss Lane, Wrightington, from a point 115 metres north west of its junction with the centreline of Crow Orchard Road for a distance of 635 metres in a north westerly direction.
- b) Ormskirk Road, Bickerstaffe, from its junction with St Helens Road to a point 245 metres north west of its junction with Liverpool Road (A506).
- c) St Helens Road, Ormskirk, from its junction with Ormskirk Road to a point 761 metres north west of its junction with the centreline of Scarth Hill Lane (C117).
