• Duxbury Manor Way, Alexander Close, Thurstan Place, Haydock Drive, Shireburne Drive, Peel Tower Close and Hodsons Fold, Chorley

Following an enquiry from a member of the public, it is proposed to introduce a 20mph speed limit from the junction of Myles Standish Way, along the full lengths of the roads on the Duxbury Manor estate.

The purpose of this proposal is to align the 20mph speed limit with the surrounding residential estates, controlling vehicular speeds in the interest of highway safety for all users.

• Bury Lane, Withnell

Following an enquiry from a member of the public it was established that there was no Speed Limit Order for the signed national speed limit on Bury Lane from the junction of A674 Bolton Road to Sunnyfield.

In the interest of highway safety for all users, it is now proposed, with the support of the police, to introduce a 40mph speed restriction to control vehicular speeds.

• Fleetwood Road – Meldar with Wesham
