THE LANCASHIRE COUNTY COUNCIL (MOUNT PLEASANT LANE, CARNFORTH AND BOLTON-LE-SANDS) DEFINITIVE MAP MODIFICATION ORDER 2018

This Order is made by Lancashire County Council ("the Authority") under Section 53(2)(b) of the Wildlife and Countryside Act, 1981 ("the Act") because it appears to that Authority that The Definitive Map and Statement of Public Rights of Way for the County of Lancashire require modification in consequence of the occurrence of events specified in Section 53(3)(b) and Sections 53(3)(c)(i)&(ii) of the Act, namely the expiration of any period such that the enjoyment by the public of the way during that period raises a presumption that the way has been dedicated as a public bridleway; the discovery by the surveying authority of evidence which (when considered with all other relevant evidence available to them) shows that (i) a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a bridleway and (ii) a highway shown in the map and statement as a highway of a particular description, namely a footpath, ought to be there shown as a highway of a different description, namely a bridleway.

The Authority have consulted with every local authority whose area includes the land to which the Order relates. Lancashire County Council hereby order that:

- 1. For the purposes of this Order, the "relevant date" is 4th July 2018.
- The Definitive Map and Statement of Public Rights of Way for the County of Lancashire shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as The Lancashire County Council (Mount Pleasant Lane, Carnforth and Bolton-le-Sands) Definitive Map Modification Order 2018.

MODIFICATION OF THE DEFINITIVE MAP

(i) DESCRIPTION OF PATH OR WAY TO BE ADDED

Addition of a bridleway from a junction with the A6, Lancaster Road, at the north west end of Thwaite End Bridge (point A on Order Map 1) passing south east over the canal bridge to a junction with Footpath Carnforth 28 (point B). The way to be added is approximately 20 metres long with a width varying between 3 and 7 metres and shown on Order Map 1 as a broken line with cross bars in the intervals.

(ii) DESCRIPTION OF PATH OR WAY TO BE UPGRADED

A continuation of the way described above, from point B on Order Map 1, running generally south south west along Mount Pleasant Lane, currently recorded as part of Carnforth 9, past Thwaite Cottage from where it is currently recorded as Carnforth 10, past Mount Pleasant Farm, crossing the parish boundary (point K on Order Map 2) from where it is currently recorded as Bolton-le-Sands 19, to Foxfield Cottage (point L) where Mount Pleasant Lane becomes designated as unclassified road U18800. The total distance to be upgraded is approximately 1.02 kilometres with a width varying between 3 and 7 metres and shown on Order Maps 1 and 2 as a broken line with cross bars in the intervals marked B-C-D-E-F-G-H-I-J-K-L.





MODIFICATION OF THE DEFINITIVE MAP

(i) DESCRIPTION OF PATH OR WAY TO BE ADDED

Addition of a bridleway from a junction with the A6, Lancaster Road, at the north west end of Thwaite End Bridge (point A on Order Map 1) passing south east over the canal bridge to a junction with Footpath Carnforth 28 (point B). The way to be added is approximately 20 metres long with a width varying between 3 and 7 metres and shown on Order Map 1 as a broken line with cross bars in the intervals.

(ii) DESCRIPTION OF PATH OR WAY TO BE UPGRADED

A continuation of the way described above, from point B on Order Map 1, running generally south south west along Mount Pleasant Lane, currently recorded as part of Carnforth 9, past Thwaite Cottage from where it is currently recorded as Carnforth 10, past Mount Pleasant Farm, crossing the parish boundary (point K on Order Map 2) from where it is currently recorded as Bolton-le-Sands 19, to Foxfield Cottage (point L) where Mount Pleasant Lane becomes designated as unclassified road U18800. The total distance to be upgraded is approximately 1.02 kilometres with a width varying between 3 and 7 metres and shown on Order Maps 1 and 2 as a broken line with cross bars in the intervals marked B-C-D-E-F-G-H-I-J-K-L.
