

NOTICE OF PROPOSAL
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(VARIOUS ROADS, PRESTON CITY AND SOUTH RIBBLE BOROUGH)
(REVOCAION AND VARIOUS PARKING RESTRICTIONS (24-25 NO1D))
ORDER 202*

NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

1. Revoke the "Lancashire County Council (Fishergate Phase 2, Various Roads, Preston, Preston City) (Revocation and Various Parking Restrictions) Order 2016" insofar as it relates to Item b) of Schedule 10.
2. The "Lancashire County Council (Preston Area) (On Street Parking Places, Prohibition and Restriction of Waiting) Consolidation Order 2009" insofar as it relates to Item (267)(ii) of Schedule 10.01.
3. Introduce a prohibition of waiting in the following lengths of road:
 - a) Chapel Lane, New Longton, the south side, from a point 10 metres east of its junction with the centreline of South Avenue for a distance of 20 metres in a westerly direction;
 - b) Cheapside, Preston, the west side, from a point 38 metres north of its junction with the centreline of Fishergate for a distance of 10.5 metres in a northerly direction;
 - c) South Avenue, New Longton, both sides, from its junction with the centreline of Chapel Lane for a distance of 14 metres in a southerly direction.
4. Introduce a prohibition of loading and unloading in Cheapside, Preston, the west side, from a point 38 metres north of its junction with the centreline of Fishergate for a distance of 10.5 metres in a northerly direction.
5. Introduce a goods vehicle loading bay in Cheapside, Preston, the west side, from a point 22 metres north of its junction with the centreline of Fishergate for a distance of 16 metres in a northerly direction.
