

NOTICE OF PROPOSAL
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(PRINCESS ROAD AND ROUGH LEA ROAD, CLEVELEYS, WYRE
BOROUGH) (REVOCATION AND PROHIBITION OF WAITING AND
LOADING) ORDER 202*

NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

1. Revoke the following:
 - a) The "Lancashire County Council (Rough Lea Road and Deby Road, Thornton Cleveleys, Wyre Borough) (Part Revocation, Prohibition of Waiting, Prohibition of Loading and Limited Waiting) Order 2014" insofar as it relates to:
 - i. Item c) of Schedule 2;
 - ii. Schedule 3;
 - iii. Item c) of Schedule 4;
 - iv. Schedule 5.
 - b) The "Lancashire County Council (Wyre Area) (On Street Parking Places, Prohibition and Restriction of Waiting) Consolidation Order 2009" insofar as it relates to:
 - i. Item (3) of Schedule 8.18;
 - ii. Items (212)a)(i), (212)a)(ii), (212)b)(i) and (212)b)(ii) of Schedule 10.01;
 - iii. Items (13)a)(i), (13)a)(ii), (13)b)(i) and (13)b)(ii) of Schedule 14.33.
2. Introduce a prohibition of waiting in the following lengths of road:
 - a) Princess Road, Cleveleys, both sides, from its junction with the Centreline of Victoria Road West for a distance of 10 metres in a northerly direction;
 - b) Princess Road, Cleveleys, both sides, from a point 84.5 metres north of its junction with the Centreline of Victoria Road West to its junction with the Centreline of Rough Lea Road;
 - c) Rough Lea Road, Cleveleys, the north west side, from its junction with the Centreline of North Promenade to its junction with the centreline of Rear 4 to 20 North Promenade.
3. Introduce a restriction of loading Monday to Saturday between 10am and 4pm in the following lengths of road:
 - a) Princess Road, Cleveleys, both sides, from its junction with the Centreline of Victoria Road West for a distance of 10 metres in a northerly direction;
 - b) Princess Road, Cleveleys, both sides, from a point 84.5 metres north of its junction with the Centreline of Victoria Road West to its junction with the Centreline of Rough Lea Road;
 - c) Rough Lea Road, Cleveleys, the north west side, from its junction with the Centreline of North Promenade to its junction with the centreline of Rear 4 to 20 North Promenade.
