

Hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and statements for the area by:

### 2. Adding the BRIDLEWAY – Lord's Lot Road, Parish: Over Kellet

**FROM**: Junction with Kirkby Lonsdale Road – B6254 Over Kellet SD 5340 6978 (A) **TO**: Junction with Borwick Road – C506 Over Kellet SD 5474 7080 (C)



This map should print at 1:11,000 scale when printed on A4 paper. See Appendix D for an unmarked copy of this map. Note: Points 1, 2, 3, 4 refer to photographs and descriptions of the current route.

#### **Description of Application Route:**

The Application Route is approximately 1.95km long and around 4 to 6m wide throughout. There is an obvious stone base to the Lane along most of its length although the section fully enclosed in the forest (Point 4 to Point C) can be muddy with puddles after rain. After the field access at Point 2 the route is markedly less used by vehicles.

From Point A to B and continuing to Point 4 it is largely hedged or fenced on both sides, with field gates allowing access to fields and properties on both sides. Nearer to C it is surrounded by forest with open access.

There is a barrier across the route at Point 3 on the above map and another just before it joins Borwick Road at Point C. These are to stop unauthorised vehicle access, but there is plenty of space to walk or ride past.

The two barriers and also the kissing gate into the forest at Point 1 have Forestry Commission signs forbidding use of motorbikes and quadbikes.

#### **Current Recorded Status:**

The route is not recorded on the Definitive Map.

The route is not recorded on the List of Streets, but is shown as "Unadopted" on LCC's Road Status Map (Road no. X1353), viewable on MARIO system. However, it was the Highways Act of 1835 which allowed for this classification and evidence points to this being a public highway from at least 1818 (see below: A1 Greenwood Map 1818 and A2 Hennet Map 1829).

#### Notes:

The route is regularly used by walkers, riders and cyclists.

The route is named Lord's Wood Road on some older maps. It refers to the same actual road.

The current junction with Borwick Road (Point C) has changed from the earlier map evidence, although both routes are shown on OS 25in 1913 Edition. The original route was still shown on OS 1:25,000 map printed in 1961. However, current mapping does not show the original route, nor is it obvious on the ground.

#### Summary and Statement of Reasons:

This route is supported by a sufficient body of evidence to be recorded as a **BRIDLEWAY**.

All evidence, spanning over 200 years, points to this being a public highway of status equal to Bridleway, even though it is not recorded on the Definitive Map.

- 1. The Application Route is clearly shown as a road on old maps (Greenwood 1818 partially and Hennet 1929 entirely). These maps were developed for sale to horse riders and coach drivers and so would strive to accurately show usable routes.
- 2. It is clearly shown as a road on all historic Ordnance Survey Maps inspected, from 1847 to 1961 including the 25 inch 1<sup>st</sup> Edition (1891) with its own plot numbers, separate to abutting land.
- 3. The route is shown clearly on the Ministry of Transport Half Inch Road Map of 1922-3. These maps were developed specifically for motorists, and showed as many classified roads as possible, which is a good indication the route was considered a public road.
- 4. The western section of the route (From Point A to Point B) is shown as a public road on the Over Kellet Tithe Map of 1847, contiguous with Kirkby Lonsdale Road, which is listed in the Tithe Apportionments as a public road. The eastern section of the route (From Point B to Point C) is shown as a road and listed in the Tithe Apportionment as "Lane" with no tithe payable, which is a god indicator this was considered a public highway.
- 5. The western section of the route (From Point A to Point B) is shown as a "white road" on the IR1910 map; that is: excluded from adjoining hereditaments, which is good evidence that this section of the route was considered a public road.
- 6. The route is shown as "Unadopted" on LCC's Road Status Map (Road no. X1353), viewable on MARIO system. However, it was the Highways Act of 1835 which allowed for this classification and evidence points to this being a public highway from at least 1818 (Greenwood 1818 and Hennet 1929). It's inclusion in the list could therefore be taken to infer that the road had been considered a public highway.
- 7. The Forestry Commission, the current owners of Lord's Lot Wood, have placed signs stating it is illegal to use motorbikes and quadbikes on the eastern section of the route, which could be taken to infer that the road is still considered a public highway of at least bridleway status.
- 8. The Land Registry holds no ownership record of the western section of the route from Point A to Point B, which is a good indication this section of the route is a public road. The eastern section (From Point B to Point C) is publicly owned and in the care of the Forestry Commission.
- 9. There are no stopping up orders found.











Here the route curves right, with field access to the left. The road is still 6 metres wide and seemingly well used by vehicles.
