THE DEFINITIVE MAP AND STATEMENT OF PUBLIC RIGHTS OF WAY FOR THE COUNTY OF LANCASHIRE

THE LANCASHIRE COUNTY COUNCIL FOOTPATH FROM HIGHER ROAD TO WELLBROW DRIVE, LONGRIDGE DEFINITIVE MAP MODIFICATION ORDER 2017

The above Order, made on the 20th September 2017, if confirmed as made, will modify the Definitive Map and Statement of Public Rights of Way for the area, by adding a Public Footpath varying in width between 0.80 metres and 3 metres from a point on Higher Road (point A on the Order Map at grid reference SD 6098 3758) running in a north westerly direction along a paved track between 71 and 71a Higher Road and continuing between garages and the boundary fences of 18 and 20 Wellbrow Drive to terminate at a junction with Wellbrow Drive at SD 6093 3763. The total length of the route is approximately 75 metres.

A copy of the Order and the Order Map may be seen free of charge at the offices of the Ribble Valley Borough Council, and at my offices from 9am to 5pm on weekdays. Copies of the order and map may be bought there at the price of £1.00.

Any representation or objection relating to the order must be sent in writing to The Director Governance, Finance and Public Services, Lancashire County Council, PO Box 78, County Hall, Preston, PR1 8XJ (REF: LSG4/PROW/CB7/888.682) not later than 29th November 2017, and applicants are requested to state the grounds on which it is made.

If no representations or objections are duly made to the Order, or if any so made are withdrawn, Lancashire County Council, instead of submitting the Order to the Secretary of State for the Environment, may itself confirm the Order. If the Order is submitted to the Secretary of State for the Environment, any representations or objections which have been duly made and not withdrawn will be sent with it.
