(BROADFIELD DRIVE AND WOODLEA ROAD, LEYLAND, SOUTH RIBBLE BOROUGH) (TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2024

NOTICE IS HEREBY GIVEN that Lancashire County Council have made an Order under **Section 14(1) (a) of the Road Traffic Regulation Act 1984**, as amended, the effect of which will be to temporarily prohibit traffic on the roads set out in this notice.

- 1. No person shall cause any motor vehicle to proceed over the following lengths of highway in the South Ribble Borough:
 - i. Broadfield Drive, Leyland from Golden Hill Lane, Leyland to Lancaster Gate, Leyland.
 - ii. Woodlea Road, Leyland from Broadfield Drive, Leyland to Back Fox Lane 6-64, Leyland.
- 2. Nothing in this order shall apply to persons engaged in the carrying out of the works.
- 3. The prohibition on Broadfield Drive, Leyland will be operative daily between 0800 hours and 1600 hours from Monday 6th January 2025 until Monday 13th January 2025 or until completion of the works within this period. The prohibitions will only be operative when indicated on site by the presence of the appropriate traffic signs in accordance with The Traffic Signs Regulations and General Directions 2016. Access for emergency services will be maintained whenever and wherever possible.
- 4. The prohibition on Woodlea Road, Leyland will be operative daily between 0900 hours and 1500 hours from Monday 6th January 2025 until Monday 13th January 2025 or until completion of the works within this period. The prohibitions will only be operative when indicated on site by the presence of the appropriate traffic signs in accordance with The Traffic Signs Regulations and General Directions 2016. The closure will be implemented to accommodate schools traffic. Access for emergency services will be maintained whenever and wherever possible.
- 5. Vehicular access for residents will be maintained whenever and wherever possible. Pedestrian access to properties will always be maintained.
- 6. An alternative route for vehicular traffic affected by the closure on Broadfield Drive, Leyland is via:-

Golden Hill Lane, Leyland – Longmeanygate, Leyland – Schleswig Way, Moss Side – Slater Lane, Leyland – Leyland Lane, Leyland – Fox Lane, Leyland – West Paddock, Leyland and vice versa.

7. An alternative route for vehicular traffic affected by the closure on Woodlea Road, Leyland is not possible owing to the fact that Woodlea Road, Leyland is a no through road.

The temporary prohibition is necessary to allow carriageway surface dressing patching works to be carried out by Lancashire County Council.
