ALBERT SQUARE, GARDEN STREET, MARKET STREET, YORK STREET, BARNOLDSWICK, PENDLE BOROUGH (TEMPORARY PROHIBITION OF THROUGH TRAFFIC) (TEMPORARY RESTRICTION OF WAITING AND LOADING OR UNLOADING) ORDER 2024

**NOTICE IS HEREBY GIVEN** that Lancashire County Council has made an Order under **Section 14(1) (a) of the Road Traffic Regulation Act 1984**, as amended, the effect of which will be to temporarily prohibit traffic on the roads set out in this notice.

- 1. No person shall cause any motor vehicle to proceed over that length of.
  - i. Albert Square, Barnoldswick from its junction with Frank Street to its junction with Ellis Street
  - ii. **Garden Street, Barnoldswick** from its junction with Newtown to outside property 4 Garden Street
  - iii. **Market Street, Barnoldswick** from its junction with Newtown to outside property 1 Market Street.
  - iv. **York Street, Barnoldswick** from its junction with Rainhall Road to its junction with Chapel Street
- 2. Nothing in this order shall apply to persons engaged in the carrying out of the works.
- 3. The prohibition will be operative.
  - i. Albert Square, Barnoldswick 0800 hours Monday 6<sup>th</sup> January 2025 until 1600 hours on Friday 31<sup>st</sup> January 2025.
  - ii. **Garden Street, Barnoldswick** 0800 hours on Wednesday 12<sup>th</sup> February 2025 until 1600 hours on Tuesday 18<sup>th</sup> February 2025.
  - iii. **Market Street, Barnoldswick** 0800 hours on Wednesday 19<sup>th</sup> February 2025 until 1600 hours on Tuesday 25<sup>th</sup> February 20245.
  - iv. **York Street, Barnoldswick** 0800 hours on Monday 10<sup>th</sup> March 2025 until 1600 hours on Friday 14th March 2025.
- 4. No person shall, except upon the direction or with the permission of a police constable in uniform, or a Civil Enforcement Officer, cause or permit any Vehicle to wait or wait for the purposes of Loading or Unloading in the lengths of road set out in Article as below.
  - i. Rainhall Road, Barnoldswick on Tuesday 18<sup>th</sup> February 2025 until Thursday 27<sup>th</sup> November 2025. Newtown
  - ii. Newtown, Barnoldswick on Wednesday 15<sup>th</sup> January 2025 until Friday 7<sup>th</sup> March 2025
- 5. Vehicular access for residents will be maintained whenever and wherever possible. Emergency services access will be maintained whenever and wherever possible. Pedestrian access to properties will always be maintained. The prohibitions will only be operative when indicated on site by the presence of the appropriate traffic signs in

accordance with The Traffic Signs Regulations and General Directions 2016. Works are weather dependent and may be carried out on any of the dates specified.

6. A diversion will be signed locally.

The temporary prohibition is necessary to allow Barnoldswick United Kingdom Shared Prosperity Fund (upgrade of town centre) works to be carried out.
