

## LANCASHIRE COUNTY COUNCIL

(C157 CRAWFORD ROAD, UP HOLLAND, WEST LANCASHIRE BOROUGH)  
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2024

**NOTICE IS HEREBY GIVEN** that Lancashire County Council have made an Order under **Section 14(1) (a) of the Road Traffic Regulation Act 1984**, as amended, the effect of which will be to temporarily prohibit traffic on the roads set out in this notice.

1. No person shall cause any motor vehicle to proceed over that length of C157 Crawford Road, Up Holland from the southern property boundary of Crawford Village Primary School to the northern boundary of property number 3.
2. Nothing in this order shall apply to persons engaged in the carrying out of the works.
3. The prohibition will be operative from 0930 hours until 1500 hours on Monday 13<sup>th</sup> January 2025 or until completion of the works within this period. **Access for emergency services will be maintained at all times.**
4. Vehicular access for residents will be maintained whenever and wherever possible. Pedestrian access to properties will always be maintained.
5. Alternative routes for vehicular traffic affected by the closure is via:-

### **Anticlockwise Diversion**


C157 Long Lane, Up Holland – U49195 Pimbo Lane, Up Holland – C157 Chequer Lane, Up Holland – C158 Ravenhead Way, Up Holland – A577 Stannanough Road, Skelmersdale – C155 Pimbo Road, Skelmersdale – C154 Whiteledge Road, Skelmersdale – U489 Nipe Lane, Skelmersdale (into St Helens Borough) – Fernyknoll Road, St Helens Borough – News Lane, St Helens Borough – Reeds Brow, St Helens Borough (into West Lancashire Borough) – C157 Crawford Road, Up Holland.

### **Clockwise Diversion**

C157 Crawford Road, Up Holland (into St Helens Borough) – Reeds Brow, St Helens Borough – News Lane, St Helens Borough – Fernyknoll Road, St Helens Borough (into West Lancashire Borough) – U489 Nipe Lane, Skelmersdale – C154 Whiteledge Road, Skelmersdale – C155 Pimbo Road, Skelmersdale – A577 Stannanought Road, Skelmersdale to Windmill Roundabout – A577 Stannanought Road, Skelmersdale – C158 Ravenhead Way, Up Holland – C157 Chequer Lane, Up Holland – U49195 Pimbo Road, Up Holland – C157 Long Lane, Up Holland.

The temporary prohibition is necessary to allow telegraph pole replacement works to be carried out by Sunbelt Rentals Ltd on behalf of BT.
