#### Let's Celebrate!

This week we are shouting a magnificent Wednesday Well Done to three settings in Lancashire who have recently has their Ofsted inspection reports published.

Linda Slattery a childminder from Oswaldtwistle shared that she is thrilled with her inspection outcome. She notes that it was the best inspection experience she's had and the day went really quick. Linda said that he inspector put her at ease as soon as she arrived. Her inspection report notes how- 'Regular evaluation helps the childminder to highlight any training needs. She keeps her knowledge up to date, seeks advice from other professionals and discusses good practice with other childminders. This helps to maintain a good standard of care and learning for children.'

Greenhouse Farm Nursery in Haslingden- Manager Lorraine Cook shared that they had two inspectors who explored and observed practice in different rooms. They sought parental feedback from 11 parents and the inspector noted just how excellent this was. Their report notes - 'Parents are extremely happy with the care their children receive. Parents comment on the 'exceptional support' they receive from leaders and staff at the setting. Staff are consistent with sharing children's development and next steps. This helps parents to continue their children's learning at home.'

Moss Lane Preschool in Lostock Hall have also had their inspection report published recently. Deputy manager Michelle Pickering shared that the day went well and the inspector put them at ease and her feedback was wonderful. The setting has very close links with parents and does close observations of children in order to know where they are up to and next steps. The inspector noted how well - 'Staff consistently start with the children's own interests and experiences, ensuring that learning is engaging and relevant. All children are provided with enriching opportunities that enhance their understanding of the world.'

Michelle's Top tip is to believe in yourself and the wonderful job you do every day, don't change anything and be consistent.

# Lancashire SEND Partnership: Inspection update



As you will know, Ofsted and the Care Quality Commission (CQC) have undertaken an inspection of the partnership support in Lancashire for children with special educational needs and disability (SEND).

The inspection team has engaged with a range of children, parents and representative groups, as well as practitioners and leaders in Social Care, Education and the NHS, to understand how we deliver support across the partnership.

Inspectors undertook a deep dive into the experiences and progress for a smaller number of children, which included speaking to those children and their parents directly, as well as the multi-agency team working with the family.

Inspectors also met with key practitioners from across the partnership and visited a range of schools, services and settings across Lancashire. We'd like to say a huge thank you to those of you who met with inspectors and facilitated visits during the inspection period. The inspectors have shared their appreciation for the warmth, passion, and commitment they have experienced as they met people from across the partnership.

We will receive a published final report around late January 2025. The Local Area Partnership will then refresh and publish its Strategic Plan for the delivery and development of SEND services, taking into account the feedback we have received from inspectors.

The <u>Domestic Abuse Support Service Lancashire</u> (DASSL) offers support in safe accommodation and outreach services for adults and children. The service is a partnership between a number of specialist domestic abuse services in Lancashire :
