SAGAR STREET, BROADWAY, CHAPEL STREET, NELSON, PENDLE BOROUGH
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2024

NOTICE IS HEREBY GIVEN that Lancashire County Council intend to make an Order under **Section 14(1) (a) of the Road Traffic Regulation Act 1984**, as amended, the effect of which will be to temporarily prohibit traffic on the roads set out in this notice.

1. No person shall cause any motor vehicle to proceed over that length of Sagar Street, Nelson from its junction with Broadway to its junction with Netherfield Road. Only one side of the carriageway will be closed at any one time.
2. No person shall cause any motor vehicle to proceed over that length of Broadway, Nelson from its junction with Sagar Street to its junction with Railway Street.
3. No person shall cause any motor vehicle to proceed over the length of Chapel Street, Nelson from its junction with Oakland Street to its junction with Holme Street in a westerly direction.
4. Nothing in this order shall apply to persons engaged in the carrying out of the works.
5.
 - i. Sagar Street - The prohibition will be operative from 0700 hours on Monday 3rd February 2025 until 1700 hours on Friday 21st March 2025 or until completion of the works within this period.
 - ii. Broadway – the prohibition will be operative from 0700 hours on Monday 17th March 2025 until 1700 hours on Sunday 4th May 2025 or until completion of the works within this period.
 - iii. Chapel Street – The prohibition will be operative from 0700 hours on Monday 3rd February 2025 until 1700 hours on Sunday 4th May 2025 or until completion of the works within this period.
 - iv. The prohibitions will only be operative when indicated on site by the presence of the appropriate traffic signs in accordance with The Traffic Signs Regulations and General Directions 2016. The road closure indicated in articles 1 and 2 will not occur at the same time.
6. Vehicular access for residents will be maintained whenever and wherever possible. Emergency services access will be maintained whenever and wherever possible. Pedestrian access to properties will always be maintained. The road will be closed on the southbound side of the carriageway using diversion as stated in part 6i. the road will be closed on the northbound side of the carriageway using diversion as stated in part 6ii.
 - i. **Southbound**
Netherfield Road – Hibson Road – Lomeshaye Road – Manchester Road – Broadway.
 - ii. **Northbound**
Broadway – Manchester Road – Lomeshaye Road – Hibson Road – Netherfield Road.
 - iii. **Broadway**
Sagar Street – Netherfield Road – Railway Street and vice versa
 - iv. **Chapel Street**
Oakland street – leeds Road – Holme Street

The temporary prohibition is necessary to allow Nelson regeneration scheme works to be carried out.
