
MARSDEN HALL ROAD, REAR 171 TO 189 BARKERHOUSE ROAD, REAR 193 TO 203 BARKERHOUSE ROAD, REAR 205 TO 215 BARKERHOUSE ROAD, REAR 217 TO 233 BARKERHOUSE ROAD AND GABLE END OF 233 BARKERHOUSE ROAD, NELSON, PENDLE BOROUGH (TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2025

**NOTICE IS HEREBY GIVEN** that Lancashire County Council intend to make an Order under **Section 14(1) (a) of the Road Traffic Regulation Act 1984**, as amended, the effect of which will be to temporarily prohibit traffic on the roads set out in this notice.

- 1. No person shall cause any motor vehicle to proceed over that length of
  - Marsden Hall Road from it junction with Barkerhouse Road to its junction with Rear 171 to 189 Barlerhouse Road.
  - ii. Rear 171 to 189 Barkerhouse Road from its junction with Marsden Hall Road to the end of the road
  - iii. Rear 193 to 203 Barkerhouse Road from its junction with Marsden Hall Road to the junction with Gable End of 203 Barkerhouse Road
  - iv. Rear 205 to 215 Barkerhouse Road from its junction with Gable End of 203 Barkerhouse Road to the junction with Rowland Avenue
  - v. Rear 217 to 233 Barkerhouse Road from its junction with Rowland Avenue to its junction with Gable End of 233 Barkerhouse Road.
  - vi. **Gable End of 233 Barkerhouse Road** from its junction with Rear 217 to 233 Barkerhouse Road to junction with Barkerhouse Road
- 2. Nothing in this order shall apply to persons engaged in the carrying out of the works.
- 3. The prohibition will be operative
  - i. Marsden Hall Road Wednesday 12th March 2025 until Thursday 27th March 2025
  - ii. Rear 171 to 189 Barkerhouse Road Wednesday 12<sup>th</sup> March 2025 until Friday 11<sup>th</sup> April 2025
  - iii. Rear 193 to 203 Barkerhouse Road Wednesday 12th March 2025 until Friday 11th April 2025
  - iv. Rear 205 to 215 Barkerhouse Road Wednesday 12th March 2025 until Friday 11th April 2025
  - v. Rear 217 to 233 Barkerhouse Road Wednesday 12th March 2025 until Friday 11th April 2025
  - vi. Gable End of 233 Barkerhouse Road Wednesday 12<sup>th</sup> March 2025 until Friday 11<sup>th</sup> April 2025
- 4. Vehicular access for residents will be maintained whenever and wherever possible. Emergency services access will be maintained whenever and wherever possible. Pedestrian access to properties will always be maintained.
- An alternative route for vehicular traffic affected by the closure is via:-Barkerhouse Road – Hazelwood Road – Hallam Road – Marsden Hall Road and vice versa

The temporary prohibition is necessary to allow gas mains replacement works to be carried out.
