(COCKER AVENUE, FURNESS DRIVE, CLARKE STREET AND ALDON ROAD, POULTON-LE-FYLDE, WYRE BOROUGH) (TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2025

NOTICE IS HEREBY GIVEN that Lancashire County Council has made an Order under **Section 14(1)** (a) of the Road Traffic Regulation Act 1984, as amended, the effect of which will be to temporarily prohibit traffic on the roads set out in this notice.

- 1. No person shall cause any motor vehicle to proceed over that length of Cocker Avenue, Furness Drive, Clarke Street, Aldon Street, Poulton-Le-Fylde.
 - i. Cocker Avenue from its junction with Furness Drive to its junction with Wood Street
 - ii. Furness Drive from its junction with Clarke Street to its junction with Cocker Street
 - iii. Clarke Street from its junction with Furness Drive to it junction with Aldon Road
 - iv. Aldon Road from its junction with Clarke Street to its junction Garstang Road East
- 2. Nothing in this order shall apply to persons engaged in the carrying out of the works.
- 3. The prohibition will be operative.
 - i. **Cocker Avenue** from 0800 hours on Monday 24th February 2025 until 1700 hours on Tuesday 11th March 2025 or until completion of the works within this period.
 - ii. **Furness Drive** from 0800 hours on Monday 10th March 2025 until 1700 hours on Friday 21st March 2025
 - iii. **Clarke Street** from 0800 hours on Monday 24th March 2025 until Friday 4th April 2025
 - iv. Aldon Road from 0800 hours on Wednesday 2nd April 2025 until Thursday 10th April 2025
- 4. Vehicular access for residents will be maintained whenever and wherever possible. Emergency services access will be maintained whenever and wherever possible. Pedestrian access to properties will always be maintained.
- 5. An alternative route for vehicular traffic affected by the closure is via:
 - i. Cocker Avenue Diversion
 - Furness Drive Beacon Road and vice versa
 - ii. Furness Drive Diversion
 - Clarke Street Aldon Road Cocker Avenue and vice versa iii. Clarke Street Diversion
 - Cocker Avenue Aldon Road and vice versa
 - iv. Aldon Road Diversion

Garstang Road East – Bracewell Avenue – Furness Drive – Clarke Street and vice versa

The temporary prohibition is necessary to allow excavate a track to install high voltage cable to be carried out.
