ROAD TRAFFIC REGULATION ACT 1984

LANCASHIRE COUNTY COUNCIL (GOOSNARGH AREA, GOOSNARGH AND WHITTINGHAM (VARIOUS ROADS), PRESTON (PART REVOCATION AND 20MPH SPEED LIMIT) ORDER 2012

The County Council of Lancashire, in exercise of its powers under Sections 82 (2) (a), 83 (2), 84 (1) (a) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

1. Part Revocation

Those parts of "The County Council of Lancaster (Restricted Roads) (No 6) Order 1969", insofar as it relates to:

- "2. That length of Church Lane (Class III) at Whittingham, in the Rural District of Preston, in the County Palatine of Lancaster, which extends from its junction with Goosnargh Lane (Class III) in a south-easterly direction to its junction with Whittingham Lane (B5269), a distance measured along the said length of road of approximately 500 yards."
- "3. That length of Goosnargh Lane (Class III) at Goosnargh, in the Rural District of Preston, on the County Palatine of Lancaster, which extends from a point 720 yards north west of its junction with Church lane (Class III) in a south-easterly direction to its junction with Mill Lane, a distance measured along the said length of road or approximately 785 yards."

Are hereby revoked.

2. 20mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on any of the roads or lengths of road set out in the schedule to this Order, located within the Goosnargh Area, Preston City.

3. Exemption

No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those Regulations.

4. Commencement of Order

This Order may be cited as the "Lancashire County Council (Goosnargh Area, Goosnargh and Whittingham (Various Roads), Preston City) (Part Revocation and 20mph Speed Limit) Order 2012" and shall come into force on the 20th day of August 2012.
