
The Lancashire County Council (“the County Council”) in exercise of its powers under **Section 14(1) (a) of the Road Traffic Regulation Act 1984**, as amended, (the Act), and of all other enabling powers, **HEREBY** makes the following Order: -

The Lancashire County Council (MARSDEN HALL ROAD, REAR 171 TO 189 BARKERHOUSE ROAD, REAR 193 TO 203 BARKERHOUSE ROAD, REAR 205 TO 215 BARKERHOUSE ROAD, REAR 217 TO 233 BARKERHOUSE ROAD AND GABLE END OF 233 BARKERHOUSE ROAD, NELSON, PENDLE BOROUGH

)(Temporary Prohibition Of Through Traffic) Order 2025, is hereby temporarily Amended in that:

- i. To amend Article 3 as follows:
3. The prohibition will be operative
 - i. **Marsden Hall Road** – Wednesday 26th March 2025 until Thursday 10th April 2025
 - ii. **Rear 171 to 189 Barkerhouse Road** – Wednesday 26th March 2025 until Friday 25th April 2025
 - iii. **Rear 193 to 203 Barkerhouse Road** - Wednesday 26th March 2025 until Friday 25th April 2025
 - iv. **Rear 205 to 215 Barkerhouse Road** - Wednesday 26th March 2025 until Friday 25th April 2025
 - v. **Rear 217 to 233 Barkerhouse Road** – Wednesday 26th March 2025 until Friday 25th April 2025
 - vi. **Gable End of 233 Barkerhouse Road** - Wednesday 26th March 2025 until Friday 25th April 2025

This Temporary Amendment Order shall come into operation on 17th March 2025 and may be cited as “**The Lancashire County Council (MARSDEN HALL ROAD, REAR 171 TO 189 BARKERHOUSE ROAD, REAR 193 TO 203 BARKERHOUSE ROAD, REAR 205 TO 215 BARKERHOUSE ROAD, REAR 217 TO 233 BARKERHOUSE ROAD AND GABLE END OF 233 BARKERHOUSE ROAD, NELSON, PENDLE BOROUGH) (Temporary Prohibition Of Through Traffic) Order 2025 (Temporary Amendment) Order 2025**”
