## Something to do this week – check your emergency procedures

To help keep both children and adults safe you should have a clear, well understood procedure in the event of an emergency inside the building leading to an evacuation or an event that happens outside your building requiring you to 'lock down'.

This week you could check your evacuation procedure and your lock down procedure are up to date. Once you have checked that suitable systems are in place, make sure that all parents, staff and volunteers are aware of these procedures and their role should an event happen.

Consider, are staff and volunteers aware? Are both imbedded in your induction procedure if you employ others? Do you record any challenges as well as the practice itself and the action you take to remove or lessen these?

#### Let's Celebrate!



This week we are shouting a wonderful well done to three settings in Lancashire who have recently had their Ofsted inspection reports published!

**Lighthouse Club and Out of School** setting in Morecambe have had their first graded inspection.

Club manager Joy shared that the experience was a positive one. The inspector asked lots of questions and talked to committee members (including the vicar), staff and parents. She spent 20 mins making paper aeroplanes with a child whilst chatting to the child. The inspector asked Joy and her staff about safeguarding and commented positively on the routines such as their arrival routines. She also looked at planning in relation to their EYFS children. Their report noted 'Staff meet all children's needs to the highest level. For example, they support children with special educational needs/and or disabilities (SEND) through talking with parents and communicating with teachers. In addition, they share information with other professionals and signpost parents to local support networks, which may be helpful for them.'

**Tracey Chimejczuk** a childminder in Oswaldtwistle shared her positive experience with us. Tracey explained that the inspection went very quickly. He spoke to parents prior to the inspection starting and he observed Tracey with the children. He asked about each child in her care and about the activities set up. He asked safeguarding and ratio questions. At one point, Tracey asked if she could take a few minutes from questioning to settle the baby and the inspector was quite happy for her to do this. Her inspection report highlights 'Communication and language development is a particular strength of

the well planned curriculum. The childminder sensitively models the correct pronunciation of words to children to support their developing speech. For example, she sits at the children's level so that they can see her mouth movements. One of Tracey's top tip is to take a breath and relax. Don't be afraid to ask for a break for a short time if you need it.

**Sarah Doyle** a childminder in Rishton has had her inspection report published, with the inspector noting 'Children keenly engage in the wide range of opportunities provided as part of the curriculum. This enables all children to make good progress. The childminder shares information about daily activities and next steps with parents to support a consistent approach in children's learning'.

Sarah shared that the inspector was lovely but the inspection was a bit of a shock because she has only been registered with Ofsted for 10 months and wasn't expecting it so soon. He asked the expected questions and spoke to her assistant about her professional development. Sarah's top tip is to be confident in what you do and say, so that the inspector feels your confidence shine through.



#### **DfE and Ofsted updates**

Big Listen action monitoring reports (Updated 17th March 2025)

Ofsted's monitoring reports on commitments made in the Big Listen and its response to Dame Christine Gilbert's independent learning review. Change made: Added 'Big Listen action monitoring report: March 2025'.

Early years qualifications achieved outside the UK (Updated 20th March 2025) How you make an application for recognition of non-UK qualifications to work in an early years setting in England. Change made: Updated to clarify information about the Ecctis early years qualification recognition service and additional information about the experience-based route (EBR) for early years staff.

Early years qualifications list: UK only(Updated 20th March 2025)

UK qualifications that meet the Department for Education (DfE) criteria for counting in the early years foundation stage statutory framework staff: child ratios. Added link to new digital early years qualification checking service for early years managers.

Early years and childcare: guidance for providers (Updated 20th March 2025) Information for early years providers, childminders and nurseries including guidance on the early years foundation stage (EYFS), funding, training and qualifications.
