

**NOTICE OF PROPOSAL**  
**ROAD TRAFFIC REGULATION ACT 1984**  
**LANCASHIRE COUNTY COUNCIL**  
**(COPP LANE AREA, ELSWICK AND GREAT ECCLESTON, FYLDE AND**  
**WYRE BOROUGHES) (REVOCATION, 20MPH AND 40MPH SPEED LIMITS)**  
**ORDER 202\***

**NOTICE IS HEREBY GIVEN** that Lancashire County Council propose to make the above Speed Limit Order under Sections 82(2), 83(2) and 84 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

1) Revoke the following:

- a) "The County Council of Lancaster (Restricted Roads) (No.9) Order 1973" in full;
- b) The "Lancashire County Council (Lodge Lane, Elswick, Fylde Borough) (Restricted Road 30mph Speed Limit) Order 2013" in full;
- c) The "Lancashire County Council (Great Eccleston Area, Great Eccleston (Various Roads) Wyre Borough) (Revocation, 20mph, 30mph and 40mph Speed Limit) Order 2013" insofar as it relates to:
  - i. Chesham Street, Copp Lane, Leckonby Street and South Street, from the Schedule;
  - ii. Copp Lane from Article 3;
  - iii. Article 4.

Where no further speed limit is re-introduced, the speed limit will revert to restricted road status by virtue of street lighting, where a 30mph speed limit will apply.

2) Introduce a 20mph speed limit in the following lengths of road:

- a) Chesham Street, Great Eccleston, the entire length;
- b) Copp Lane, Great Eccleston, from its junction with Leckonby Street/South Street to a point 201 metres south west of its junction with the centreline of Admarsh Drive;
- c) Leckonby Street, Great Eccleston, the entire length;
- d) South Street, Great Eccleston, the entire length.

3) Introduce a 40mph speed limit in the following lengths of road:

- a) Copp Lane, Elswick, from its junction with Copp Lane, Great Eccleston to a point 354 metres north of its junction with Beech Road;
- b) Copp Lane, Great Eccleston, from a point 201 metres south west of its junction with the centreline of Admarsh Drive to its junction with Copp Lane, Elswick.
