

c) That part of Public Footpath No. 309 Rawtenstall, Rossendale Borough, from a point approximately 172 metres to the south-west of its junction with Holme Lane, Rawtenstall (GR SD 8008 2177), running in a general southerly direction for a distance of approximately 100 metres to GR 80907 2166, will be stopped up; and

d) a route be created from a point on the existing line of Public Footpath No. 309, Rawtenstall, Rossendale Borough, approximately 1723 metres to the south-west of its junction with Holme Lane, Rawtenstall, (GR SD 8008 2177), running in a general westerly direction for a distance of approximately 30 metres, then in a gnereal southerly direction for a distance of approximately 60 metres, and then in a general south-easterly direction for a distance of approximately 62 metres to rejoin Public Footpath No 309, Rawtenstall at GR 8007 2166:

as shown on the Order plan.

This creation of the route described at b) above comes into force on the 31st October 2006, and the extinguishment of the route described at a) above will be when the created route is certified as fit for use, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that a requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under Paragraph 2 of Schedule 2 to the Act as applied by Paragraph 5 of Schedule 6 to the Act, within six weeks from the 27 October 2006, make an application to the High Court.
