(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2025

NOTICE IS HEREBY GIVEN that Lancashire County Council has made an Order under **Section 14(1) (a) of the Road Traffic Regulation Act 1984**, as amended, the effect of which will be to temporarily prohibit traffic on the roads set out in this notice.

1. No person shall cause any motor vehicle to proceed over that length of
 - i. **Hexham Avenue** from its junction with Northumberland Avenue to its junction with Ring Way.
 - ii. **Oxenholme Avenue** from its junction with Tebay Avenue to its junction with Cleveleys Avenue.
 - iii. **Seaton Avenue** from its junction with Hexham Avenue to its junction with Ringway.
 - iv. **Cleveleys Avenue** from its junction with Cumberland Avenue to its junction with Ringway.
 - v. **Consett Avenue** from its junction with Cleveleys Avenue to the end of the road.
 - vi. **Blythe Avenue** from its junction with Consett Avenue to its junction with Northumberland Avenue.
 - vii. **Whiteley Avenue** from its junction with Blythe Avenue to its junction with Cleveleys Avenue.
 - viii. **Allonby Avenue** from its junction with Ringway to the end of the road.
 - ix. **Kirkby Avenue** from its junction with Ringway to its junction with North Drive.
2. Nothing in this order shall apply to persons engaged in the carrying out of the works.
3. The prohibition will be operative daily from 0930 hours until 1500 hours on Friday 9th May 2025 until Friday 6th June 2025 or until completion of the works within this period. The prohibitions will only be operative when indicated on site by the presence of the appropriate traffic signs in accordance with The Traffic Signs Regulations and General Directions 2016. Works are weather dependent and may be carried out on any of the dates specified.
4. Vehicular access for residents will be maintained whenever and wherever possible. Emergency services access will be maintained whenever and wherever possible. Pedestrian access to properties will always be maintained.

5. An alternative route for vehicular traffic affected by the closure is via:-

- i. **Hexham Avenue** Northumberland Avenue - Ringway and vice versa.
- ii. **Oxenholme Avenue** Tebay Avenue – Egremont Avenue – Cleveleys Avenue and vice versa.
- iii. **Seaton Avenue** Hexham Avenue – Northumberland Avenue – Ringway and vice versa.
- iv. **Cleveleys Avenue** Northumberland Avenue – Ringway – Blaydon Avenue – North Drive – Cumberland Avenue and vice versa.
- v. **Consett Avenue** Blythe Avenue – Whitely Avenue – Cleveleys Avenue and vice versa.
- vi. **Blythe Avenue** Northumberland Avenue – Cleveleys Avenue – Consett Avenue and vice versa.
- vii. **Whiteley Avenue** Cleveleys Avenue – Consett Avenue – Blythe Avenue and vice versa.
- viii. **Allonby Avenue** no diversion available due to location.
- ix. **Kirkby Avenue** Ringway Blaydon Avenue – North Drive and vice versa.

The temporary prohibition is necessary to allow surface dressing works to be carried out.
