A: Property Register

This register describes the land and estate comprised in the title.

- 1 (16.07.1920) The Freehold land shown edged with red on the plan of the above Title filed at the Registry and being Land at Mere Farm, Mere Lane, Mere Brow, Tarleton (PR4 6JU).
- 2 The Transfer dated 16 March 1987 referred to in the Charges Register contains the following provision:-

"IT IS HEREBY AGREED AND DECLARED by and between the Transferor and the Transferee that as between the plot of land hereby transferred and the remainder of the land comprised in title above mentioned all rights in the nature of common or quasi-easements shall remain as hitherto existed and be as necessary repaired and maintained accordingly"
- 3 (18.07.1996) The land has the benefit of the rights granted by but is subject to the rights reserved by the Transfer dated 28 June 1996 referred to in the Charges Register.
- 4 (18.07.1996) The Transfer dated 28 June 1996 referred to in the Charges Register contains provisions as to light or air and boundary structures.
- 5 (18.08.2021) A new title plan based on the latest revision of the Ordnance Survey Map has been prepared.

B: Proprietorship Register

This register specifies the class of title and identifies the owner. It contains any entries that affect the right of disposal.

Title absolute

- 1 (18.07.1996) PROPRIETOR: WILLIAM THOMPSON, GLENYS KATHRYN THOMPSON and JOHN THOMPSON of Mere Farm, Mere Lane, Mere Brow, Tarleton, Lancs, PR4 6JU.
- 2 (18.07.1996) RESTRICTION: No disposition by a sole proprietor of the land (not being a trust corporation) under which capital money arises is to be registered except under an order of the registrar or of the Court.

B: Proprietorship Register continued

- 3 (18.08.2021) RESTRICTION: No disposition of the part of the registered estate shown tinted pink on the title plan by the proprietor of the registered estate is to be registered without a written consent signed by the proprietor for the time being of the Charge dated 26 October 2020 in favour of National Westminster Bank PLC referred to in the Charges Register.

C: Charges Register

This register contains any charges and other matters that affect the land.

- 1 Mere Lane is subject to rights of way.
- 2 The land is subject to the following rights granted by a Transfer of the land edged yellow on the filed plan dated 16 March 1987 made between (1) The Lancashire County Council (Transferor) and (2) British Gas Plc (Transferee):-
- "Together with a right of way with or without vehicles (in common with the Transferor and all others who may have or who hereafter may have a like right) at all times and for all reasonable purposes in connection with the use of the land hereby transferred over the length of Mere Lane aforesaid shown coloured brown on the said plan subject to the payment of a fair proportion of the cost of maintenance and repair thereof."
- NOTE: The land coloured brown on the plan referred to above is hatched blue on the filed plan.
- 3 The part of the land affected thereby is subject to the rights granted by a Deed dated 16 March 1987 made between (1) Lancashire County Council and (2) British Gas Plc. The said Deed also contains restrictive covenants.
- NOTE: Copy filed under LA227616.
- 4 (18.07.1996) A Transfer of the land in this title dated 28 June 1996 made between (1) Lancashire County Council and (2) William Thompson and others contains covenants, a right of re-entry and subsequent determination of this title upon the conditions and otherwise as is therein contained and takes effect subject to the provisions for the release of covenants and the right of re-entry upon payment of additional money contained in a Deed of Covenant of that date made between the same parties.
- NOTE: Copy Deed of Covenant filed.
- 5 (18.07.1996) REGISTERED CHARGE dated 28 June 1996 to secure the moneys including the further advances therein mentioned.

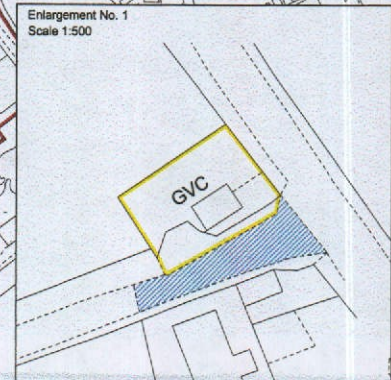
