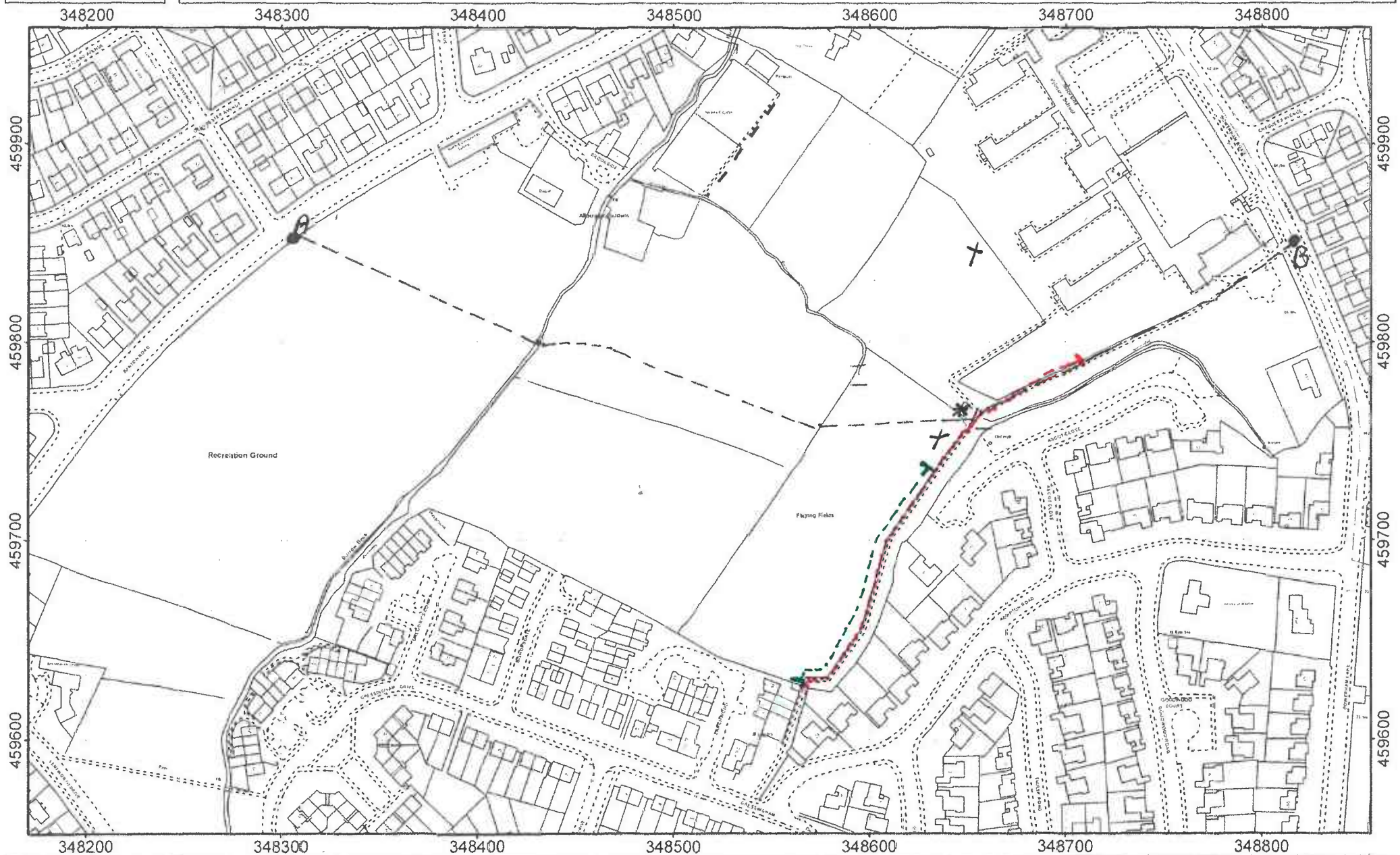

Explanatory Notes - Statements on evidence forms

- 1/ An old metal fence was removed and replaced by a longer new fence in the first quarter of 2008. The new fence coincided with the upgrading of an existing footpath to a cycle path which opened May/June 2008. See map attached to evidence form MICHAEL WORTH.

At the planning stage of this upgrading representations were made by members of this community group to the local authority to consider a hard core turning circle in the area where the gate is * on the map; thus to facilitate a turning circle for the vehicles and trailer carrying grass mowing equipment. The area of the playing field near the gate floods badly - vehicles get stranded. No response was given.
